(1) Modified Stage -I in Principal approval No. 5-ORC 391/2019-BHU dated 25th January 2024 by Regional Office, Bhubaneswar of MoEF & CC.

(2) This office letter No. 1209 dated 28.02.2024

Sir/Madam.

With respect to the above subject and as per modified Stage - I Principal approval dated 25th January 2024, Point No – III, "the State Govt. will realize Penal NPV of (five) 5 times of the NPV from the User Agency for violation of FC Act,1980". Page No - 41, point (ii) consolidated guidelines and clarifications issued under VAN (SANRAKSHAN EVAM SAMVARDHAN) ADHINIYAM 1980 and VAN (SANRAKSHAN EVAM SAMVARDHAN) RULES, 2023 reads that,

The penalty for violation shall be equal to NPV of Forest Land per hectare for each year of violation from the date of actual violation, as reported by inspecting Officer, with maximum up to 5 times of NPV plus 12% simple interest, from the date of raising such demand.

The violation was reported in 11.05.2021 by DFO, Paralakhemundi. On February 2024, the violation was reported 990 days ago (2.71 Years).

Area under violation is 10.356 Ha.

Penalty to be paid is (10.356 X 1116900 X 2.71 (Number of years)

= Rs. 3,13,45,530/-

Simple interest @12% for 3 Months (Assuming payment to be made by 31st May 2024)

= Rs. 9,40,366/-

Total = Rs. 03,22,85,896/

The Forest is Eco class – 1 and open Forest. So NPV of 1116900 is taken for calculation.

So, you are requested to pay on Rs. 03,22,85,896 (Rupees Three Crore twenty-two lakhs eighty-five thousand eight hundred ninety-six) only as penal NPV for the violation.
