With reference to the above cited letters under subject, this is to inform you that Integrated Regional Office of MoEF & CC Govt. of India vide their letter No. 5-ORC519/2022-BHU dated 02.08.2022 have accorded in principle approval under section -2 of the Forest (Conservation) Act-1980 for non-forestry use of 7.742 ha. of forest land for widening strengthening of (Kotagarh-Subarnagiri-Srirampur Road) MDR 60A from 8/000 Km to 17/000 Km and 24/500 Km to 30/000 Km under Balliguda Forest Division in Kandhamal District.

Therefore, as per condition No. A (i) of the approval order of the Govt. of India, Mo EF & CC, you are requested to deposit an amount of Rs. 74,15,133 /- (Rupees Seventy four lakh fifteen thousand one hundred thirty three) only towards the cost Net Present Value (NVP) for approved nonforestry use of 7.742 ha. of forest land pertaining to this Forest Division as per the calculation given below.
