With reference to the subject cited above, I am directed to inform you that the Government of India vide letter No. No. 3 AS C 014/2017-SHI/942-43 dated 18.09.2017 granted "In-Principle Approval" to the Proposal No. FP/AS/ROAD/22913/2016 in respect of diversion of 10.583 hectares of forest land in Borail Reserve Forest for up gradation of 4 lanning Balacherra – Harangajao Section of NH 54 (E) under E.W. corridor project under Dima Hasao Forest (West) Division, Haflong.
