With reference to the above cited memos on the captioned subject, it is to inform that, as per instruction of the Conservator of Forests, (Nodal) O/o the Pr.C.C.F, Odisha, Bhubaneswar, Avenue Plantation Scheme for 12250 nos. seedlings has been submitted to RC.C.F, Berhampur Circle and the same has been approved @₹315/- per MD amounting to ₹ 4,59,58,374/-. Due to revision of wage rates the Avenue plantation scheme has been revised and technically approved @ ₹ 326/ - per MD amounting to ₹ 4,65,58,576/-. Further, the revision of wage rates has caused the Compensatory Afforestation Scheme over an area of 7.20 Ha. of degraded forest land identified in Parapit RF of Purunakatak range, Boudh Division to be revised and approved @ ₹ 326/- per MD amounting to ₹ 11,36,600/- by the C.C.F. Forest Diversion & Nodal Officer, F.C. Act.

Furthermore, the Net Present Value (NPV) has been revised vide letter no. File No. 5-3/2011-FC(Vol-I) dt. 19.01.2022 and as per point no. ii, the NPV shall be revised as the aforesaid diversion proposal was obtained In-principal approval before 06.01.2017.

In inviting a kind reference to the subject cited above, it is to state that the Stage-I forest clearance has been obtained on dated 26.02.2016 (Copy enclosed) subjected to fulfilling of all the terms and conditions of MOEF&CC, Govt. of India, in which as per Clause No.2(vii) stating that "The user agency shall comply the conditions stipulated by state Govt. vide letter no. 10(Cons) 8/2016 - 2166/ F&E dated 03.02.2016"(Copy enclosed), As per the point no. 15 of the aforesaid letter no. 10(Cons) 8/2016 - 2166/ F&E dated 03.02.2016 of Forest & Environment department, Govt of Odisha, planting of 12250 no. of trees against the cutting of 1225 no. of trees under the scheme of Avenue Plantation on both side of the instant road as well as feeder road to be prepared by the user agency.

Accordingly the Avenue Plantation estimate has been prepared for an amount of Rs 1, 05, 36,993/- and also deposited to the Divisional Manager, OFDC, Boudh on dated 01/12/2017 as per the demand raised by the DM,OFDC, Boudh towards the plantation of 12250 no. of trees. Subsequently the said amount has been returned back by DM, OFDC, Boudh as per the instruction of PCCF, & HOEF, Cdisha vide their letter no. 1065

dated 18.01.2022.

Since the stage-II clearance has not been obtained due to non satisfying the entire terms and conditions of stage-I approval at that time. Now the Avenue plantation scheme has been revised as per current labour rate (@ 326/Mandays), accordingly revised estimate has been prepared by DFC, Boudh and subsequently approved by RCCF, Berhampur which comes to an amount of Rs. 4,81,22,304/-

Therefore, the bill of difference amount of Rs 3,75,85,311/- (i.e. Rs 4 81, 22,304 - Rs 1,05,36,993) is submitted to your good office for payment.
