उपरोक्त विषयान्तर्गत मुख्य वन संरक्षक, जोधपुर के पत्रांक 3776 दिनांक 20.07.2021 से प्राप्त प्रकरण की सैद्धान्तिक स्वीकृति की बिन्दुवार पालना रिपोर्ट निम्नानुसार है:—

1.	Legal status of the Forest land shall remain unchanged	The Legal Status of the forest land for construction of 765 KV DC Fatehgarh-II to Bhadla-II Transmission line admeasuring 4.95 ha will remain unchanged. <b>Undertaking is Enclosed.</b>
2.	Compensatory afforestation shall be taken up by the Forest Department over 15.00 ha. degraded Forest land in Compartment No. Osian-4, Village - Osian, Range Osian. District Jodhpur at the cost of the User Agency. As far as possible, a mixture of local indigenous species shall be planted and monoculture of any species may be avoided.	Charges for Compensatory afforesation for degraded Forest land in Village - Osian, Range Osian. District Jodhpur has been paid as suggested by the forest department. Mixture of local indigenous species also considered. <b>Under taking for the same enclosed.</b>
3.	The cost of compensatory afforestation at the prevailing wage rates as per compensatory afforestation scheme and the cost of survey, demarcation and erection of permanent pillars if required on the CA land shall be deposited in advance with the Forest Department by the project authority. The CA will be Maintained for 10 years. The scheme may include appropriate provision for anticipated cost increase for works scheduled for subsequent years. The State Government shall charge the Net Present Value (NPV) for the 2.8874 ha forest area to be diverted under this proposal from the User Agency as per the orders of the Hon'ble supreme Court of India dated 30/10/2002, 01/08/2003, 28/03/2008, 24/04/2008 and 09/05/2008 in IA No. 566 in WP © No. 202/1995 and as per the guidelines issued by the Ministry vide letters No. 5-1/1998-FC (Pt.II) dated 18/09/2003, as well as letter No. 5-2/2006-FC dated 03/10/2006 and 5-3/2007-FC dated 05/02/2009 in this regard.	Charges for NPV has been paid in CAMPA Fund Amount of Rs 21,68,100 ( Twenty One Lakhs Sixty Eight Thousand One hundred Rupees) vide E-Challan 6444930833 dated 30.06.2021 and UTR No SBIN421183305415 dated 02.07.2021. <b>Undertaking for the same Enclosed.</b>
5.	Additional amount of the NPV of the diverted forest land, if any, becoming due after finalization of the same by the Hon's Supreme Court of India on receipt of the report from the Expert Committee, Shall be charged by the State Government from the User Agency. The User Agency shall furnish an undertaking to this effect.	<b>Undertaking for the same Enclosed.</b>
6.	User agency shall restrict the felling of trees to minimum number in the diverted forest land and the trees shall be felled under the strict supervision of the State Forest Department and the cost of felling of trees shall be deposited by the User Agency with the State Forest Department.	<b>Undertaking for the same enclosed.</b>
7.	The complete compliance of the FRA, 2006 shall be ensured by way of prescribed certificate from the concerned District Collector.	<b>FRA Certificate No Revenue/Forest/ Diversion/21/3028 dated 10.06.2021 from the District Collector enclosed.</b>
8.	The User agency in consultation with the State Forest Department prepare a detailed scheme for creation and maintenance of plantation of dwarf species (preferably medicinal plants) in right of way under the transmission line and deposit the cost for execution of the said scheme to the State Forest Department.	Charges deposited for plantation of dwarf species (preferably medicinal plants) in consultation with State Forest Department, Amount of Rs 29,06,145/- (Twenty Nine Lakhs Six Thousand One Hundred Forty Five Rupees Only) vide E-Challan 6444930833 dated 30.06.2021 and UTR No SBIN421183305415 dated 02.07.2021. <b>Undertaking for the same enclosed.</b>
9.	(a) The user agency at its cost shall provided bird deflectors, which are to be fixed on upper conductor of transmission line at suitable intervals to avoid bird hits. (b) Line marker of constract colours should be placed at a distance of 5 to 10 meters. (c) The bird deflectors should cover 100%	<b>Undertaking for the same enclosed.</b>



10.	The User Agency shall comply with the guidelines for laying transmission lines through forest areas issued by Ministry vide letter no. 7-25/2012-FC dated 05/05/2014 & 19/11/2014.	<b>Undertaking for the same enclosed.</b>
11.	The User Agency shall obtain Environmental Clearance as per the provisions of the Environmental (Protection) Act 1986. if applicable.	<b>Undertaking for the same enclosed.</b>
12.	The layout plan of the proposal shall not be changed without prior approval of Central Government.	<b>Undertaking for the same enclosed.</b>
13.	No labour camp shall be established on the forest land.	<b>Undertaking for the same enclosed.</b>
14.	Sufficient firewood, preferably the alternate fuel, shall be provided by the User Agency to the labourer after purchasing the same from the State Forest Department or the Forest Development Corporation or any other legal source of alternate fuel.	<b>Undertaking for the same enclosed.</b>
15.	The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost, as per the directions of the concerned Divisional Forest Officer.	<b>Undertaking for the same enclosed.</b>
16.	No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work.	<b>Undertaking for the same enclosed.</b>
17.	The Period of diversion under this approval shall be co-terminus with the period of lease to be granted in favour of the user agency or the project life, whichever is less.	<b>Undertaking for the same enclosed.</b>
