Vide reference 6th cited, the Government of India, Ministry of Environment, Forest and Climate Change, IRO, Hyderabad has accorded Stage-I (in-principle) approval for Diversion of 0.8621 Ha of forest land in various RFs of Siddipet Forest Division of Siddipet District for laying of Optical Fiber cable along the road and within the existing Row for execution of T Fiber Project in favour of M/s Telangana Fiber Grid Corporation Ltd. Hyd.

Vide reference 7th cited, the Prl. Chief Conservator of Forests, TS, Hyderabad has instructed this office to submit the demand notice to the Circle head for vetting and raise the demand with the User Agency after approval, for payment of compensatory levies like Net Present Value, compensatory Afforestation, protection structures Etc., and also requested to obtain the compliance report on the conditions stipulated in Stage-I (in-principle) approval from the user Agency and furnish for obtaining Stage II (final) approval from the Government of India.

Further vide 10th ref, the Prl. Chief Conservator of Forests, TS, Hyderabad has instructed to revise the Demand Notice issued by this office vide 9th ref .

Hence accordingly the revised demand notice is prepared and the following are the amounts to be deposited by the User Agency:

The M/s Telangana Fiber Grid Corporation Ltd. Hyd is requested to upload the Demand Notice at Ministry's portal i.e., <http://parivesh.nic.in/> against the proposal number for verification and acceptance of demand notice by the Nodal Officer, FCA for accepting the demand online in the forest clearance portal. After accepting the demand notice by the Nodal Officer, the User Agency shall generate e-challan and deposit the funds into the Telangana State Compensatory Afforestation Fund Management and Planning Authority (CAMPA) account of Telangana against the Challan number. The step-by-step process involved is available at Ministry's portal

Further, the User Agency has to comply with following in accordance with the MoEF&CC, GoI instructions issued vide F.no.7-23-2012-FC, Dt.24.07.2013 communicated vide Prl. Chief Conservator of Forests, A.P. Hyderabad Rc.No.45921/2001/F4, Dt.23.08.2013:

1. Publish the entire forest clearances granted in verbatim along with the condition and safe-guards imposed by the Central government in two widely circulated daily newspaper one in vernacular language and the other in English granted to the project proponent for the use of forest land for the non-forest purposes.
2. The copies of the forest clearance should also be submitted to the heads of local bodies, Panchayaths and municipal bodies by the project proponents in addition to the relevant offices of the Government who in turn has to display the same for 30 days.

The User Agency shall also furnish the compliance on the conditions stipulated in the Stage I (in-principle) approval for onward submission to Government for obtaining Stage-II (final) approval.

The transfer of forest land to User Agency shall not be affected prior to the issue of final (Stage II) approval or working permission.

In view of the above the M/s Telangana Fiber Grid Corporation Ltd. Hyd. is requested to kindly make the payment and submit the compliance report on the Stage-I approval for obtaining the final (Stage-II) approval.
