1	Legal status of the diverted forest land shall remain unchanged;	The User Agency has Agreed
2	Forest land will be handed over to the User Agency only after required non-forest land for the project is handed over by the User Agency.	After the non forest land is acquired by the user agency forest land will be handed over to them.
3	Compensatory afforestation shall be taken up by the Forest Department over 8.00 ha degraded forest land, in Survey No.372 pt., Village-Anklas, Taluka-Umargam, District-Valsad, Gujarat at the cost of the User Agency. As far as possible, a mixture of local indigenous species shall be planted and monoculture of any species shall be avoided. 

5	<p>NPV:</p> <p>a) The State Government shall charge the Net Present Value (NPV) for the 3.788 ha. forest area to be diverted under this proposal from the User Agency as per the orders of the Hon'ble Supreme Court of India dated 30.10.2002, 01.08.2003, 28.03.2008, 24/04/2008 and 09.05.2008 in IA No. 566 in WP (C) No. 202/1995 and as per the guidelines issued by the Ministry vide letters No. 5-1/1998-FC (Pt. II) dated 18.09.2003, as well as letter No. 5-2/2006-FC dated 03/10/2006, 5-3/2007-FC dated 05/02/2009 and chapter 3 of FCA-1980 Handbook 2019 in this regard.</p>	The User Agency has already deposited an amount of Rs. 27.65.240/- towards the cost of Net Present Value in the CAMPA fund.
	b) Additional amount of the NPV of the diverted forest land, if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert Committee, shall be charged by the State Government from the User Agency. The User Agency shall furnish an undertaking to this effect.	The User Agency has already given the undertaking in this regard
6	User Agency shall restrict the felling of trees up to 188 numbers in the diverted forest land and trees shall be felled under the strict supervision of the State Forest Department. The cost of felling of trees shall be deposited by the User Agency with the State Forest Department.	The User Agency has Agreed

7	All the funds received from the user agency under the project shall be transferred/ deposited in CAMPA fund only through e-portal (https://parivesh.nic.in).	Funds from the user agency has been online transferred to the CAMPA fund through e –portal.
8	Submission and uploading of Sol toposheet map of CA land along with compliance report of Stage-I approval.	Sol toposheet map of CA land is upload on e-portal.
9	The certificate of Collector under FRA, 2006 for proposed CA land as per para 6.3e(ii) of CA rules-2003 shall be submitted and uploaded on the web portal along with compliance report of Stage-I approval.	The User Agency has Agreed
10	User Agency shall obtain Environmental Clearance as per the provisions of the Environmental (Protection) Act, 1986, if required.	Environment Clearance is not required in the above proposal.
11	User agency shall raise strip plantation on both sides and central verge of the road as per the IRC norms.	The user agency has stated that as per prevalent IRC norms and guidelines, every effort will be made to raise strip plantation on both side/central verge of the road.
12	Speed regulating signage will be erected along the road at regular intervals in the Protected Areas/ Forest Areas, if applicable.	The User Agency has Agreed
13	The user agency shall provide suitable under/ over pass in the Protected Areas/ Forest Areas as per recommendations of CWLW/ NBWL/ FCA/ REC, if applicable.	The User Agency has Agreed
14	The layout plan of the proposal shall not be changed without prior approval of the Central Government.	The User Agency has Agreed
15	No labour camp shall be established on the forest land.	The User Agency has Agreed
16	Sufficient firewood, preferably alternate fuel, shall be provided by the User Agency to the laborers after purchasing the same from the State Forest Department or the Forest Development Corporation or any other legal source of alternate fuel.	The User Agency has Agreed
17	The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost, as per the directions of the concerned Divisional Forest Officer	The User Agency has Agreed

18	No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work.	The User Agency has Agreed
19	The period of diversion under this approval shall be co-terminus with the period of lease to be granted in favour of the user agency or the project life, whichever is less.	The User Agency has Agreed
20	The forest land shall not be used for any purpose other than that specified in the project proposal.	The user agency has undertaken that the forest land shall not be used for any purpose, other than that specified in the FCA proposal.
21	The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval of Govt. of India.	The User Agency has Agreed
22	All the condition of State forest Department /Local forest rules shall be applicable in this project.	The User Agency has Agreed
23	Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as per para 1.21 of FCA, 1980 Handbook 2019.	The User Agency has Agreed
24	Any other condition that the Ministry of Environment, Forests & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forests & wildlife.	The User Agency has Agreed
25	The compliance report in the letter format of govt. of Gujarat shall be uploaded on e-portal (https://parivesh.nic.in).	The Compliance report is uploaded on e-portal.
