A Brief Summery on Compensatory Afforestation Land and Compensatory Afforestation Amount deposited

Considering the fact in the year 2013, GSPL's various pipeline projects was going on in the entire Gujarat State and as directed by forest dept., **GSPL had offered 20.4620 ha of non-forest land bank in village Dadhiyali, Taluka Khambha, District Amreli** to forest deptt. against diversion of forest land for GSPL's ongoing and upcoming projects.

The offered land had been purchased, **mutated in the revenue records in the name of forest dept. and further physical position of land also handed to forest deptt. on 17.07.2014.** Land Mutation copy is attached as **Annexure B1 & B2.** Land Position receipt handed over for Forest Dept. is attached as **Annexure-C.**

We wish to add here that total 47.7380 ha of land bank handed over to Forest Dept. at this location wherein 20.4620 ha was purchased and handed over to Forest Dept by GSPL and 27.2760 ha by Gujarat Gas Limited (Earlier GSPC Gas Company Limited).

Further forest dept. has prepared Compensatory Afforestation (CA) Scheme for the whole 47.7380 ha of land and after approval from competent authority demand note for deposition of CA amount bifurcated based on the area purchased and intimated to deposit of Rs.41,79,698/- to GSPL for 20.4620 ha land bank vide letter dated 18.09.2014.

The details of CA land and payment deposited for the above land bank are furnished below.

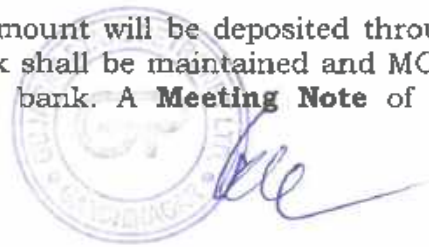
CAMPA office has also confirmed the receipt of the above payment vide their letter no. 1-12/2013-CAMPA dtd. 11.01.2017 against one of our 1.6114 ha. of forest diversion proposal **(Annexure-D)**

We further to inform that while processing **3.165 ha of forest diversion proposal** of Chotila-Anjar Pipeline project at MOEF RO Office Bhopal, it came to their notice that CA amount deposited by GSPL in the year 2014 however plantation on the allotted land bank has not been done till date.

Therefore as per the direction of MOEF RO office a joint meeting has been scheduled in the office of Nodal officer Gujarat State Gandhinagar on 07.02.2020 between MOEF RO, State Nodal Officer and GSPL.

The meeting was chaired by Dy. Director General of Forest (Central). During discussion Dy. DG of forest (central) directed to Nodal officer to prepare revised CA scheme as per the current rate to ensure plantation in the allotted land bank in the next financial year. They also directed to GSPL to pay the difference of amount of the CA scheme.

It was also informed in the meeting that difference of CA amount will be deposited through 3.165 ha. of diversion proposal and an account of land bank shall be maintained and MOEF will approve all the proposals, proposed from above land bank. A **Meeting Note** of the discussion had is attached herewith As **Annexure-E.**



Further **Revised CA scheme for Rs. 88,01,255/-** has been prepared by DCF, Dhari East Division. and Nodal officer forwarded the same to MOEF RO office through 3.165 ha. of forest proposal, for approval vide letter no. FCA/29-C/A/19-20/2020-21 dtd. 13.05.2020

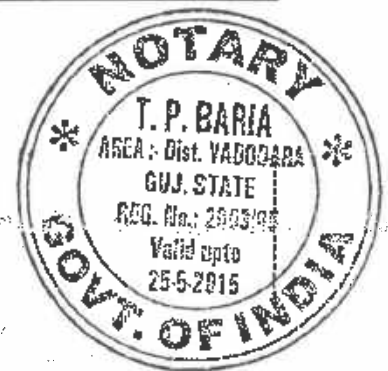

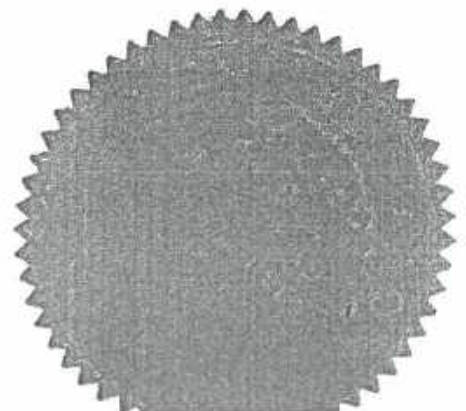

Points discussed:

- ED, GSPL briefed about the company and existing, upcoming GSPL pipeline network in the state of Gujarat.
- GSPL briefed that diversion of 3.165 ha of forest land in Anjar-Chotila Pipeline Project has been recommended 4th time from State Govt. on 19.12.2020. Initially proposal was recommended on 17.02.2018. GSPL explained that 100% ROU acquisition and statutory permissions has been secured except forest permission. Environmental Clearance has been approved but not issued for the want of Stage-I forest clearance.
- GSPL also explained about upcoming Chhara Connectivity project and requested to issue In-Principal forest permission which is lying with RO office.
- GSPL briefed about the proposals which are lying with MOEF RO office and for In-Principal /Final permission.
- GSPL briefed that following Land Banks handed over in advance to Forest Deptt. in 2011 and 2014 and diversion of forest proposals being adjusted from below mentioned land banks.
 1. 9.1256 Ha of land bank of Svy. No. 55/P1, Village Vavdi, Taluka Mahuva, Dist. Bhavnagar
 2. 20.4620 Ha of land bank of Svy. No. 53/1/P2 and 53/1/P3, village Dadhiyali, Taluka Khambha, Dist. Amreli
- GSPL also informed that payments towards Compensatory Afforestation scheme for the whole land bank has already been paid at the time of handing over the land and same has been transferred to CAMPA by Nodal office.
- Dy. Director General of Forest informed that he has gone through the above land banks in details and through DSS reports and forest sources we came to know that plantation of the land bank has still not been done, though GSPL has deposited the payment in the year 2011, 2013.
- Dy. DG of forest confirmed the same from Nodal Officer also. Further they informed that revised CA scheme has to be prepared as on date. GSPL has to bear the cost of difference to CA amount and State Govt./ Nodal officer has to ensure for plantation by the next financial year.
- GSPL agreed to pay the difference of CA amount.

- Nodal officer also agreed to revise the CA scheme within a week time.

Dy. DG of Forest informed that on deposition of difference of CA amount of In-Principal and Final permission will be issued.

- GSPL requested to guide, how to deposit the difference of CA amount as payment can only be deposit against any proposal by generating challan through forest portal.
- Dy. DG of forest confirmed that Nodal officer will send revised CA scheme, difference amount to be deposited and Undertaking of GSPL showing willingness to deposit the payment, to MOEF RO office, as soon he received.

Further RO office will issue In-Principal approval of 3.165 ha of forest proposal. The deference of CA amount may be deposited in addition to NPV and other levies (if any) by generating challan against 3.165 ha of forest proposal.

- Dy. DG of forest informed after deposition of payment Nodal officer will communicate with list of proposals proposed through above CA lands MOEF RO Bhopal will issue final permissions for all the proposal without any delay.
- Further onward the same list (addition the new proposal) should be submitted while recommending the new proposal to MOEF RO office Bhopal for Stage-I and Stage -II clearance.
- Further GSPL briefed about two forest proposals (diversion of 3.6068 ha and 1.1162 ha) for which In-Principal permission was issued on 2007 & 2008 and revoked by MOEF RO office on 25.03.2014 and 31.03.2014 for non-submission of compliance to MOEF RO within prescribed time limit.

GSPL explained that final compliance was submitted timely to forest Dept. and also recommend through proper channel to State Govt. for further recommendation to MOEF for final approval, however in the meantime both the proposals has been revoked.

GSPL informed that they have submitted the clarification in details to MOEF RO office as well as Nodal office and State Govt. Further in light of the guideline of MOEF New Delhi vide F.No. 11-103/2016-FC dtd. 31.03.2017, State Govt recommended both the proposals for consideration and issuing final permission.

- Dy. DG of Forest taken a copy of recommendation letter of State Govt. and ensured to do the needful in the matter. He further suggested that revised CA and NPV (if any) as on date has to be paid to regularize the proposal. GSPL informed that CA land has been provided from Svy. No. 15/1/P3 of village Dharadungri, Taluka Sayla, District Surendranagar and agreed to pay the revised CA amount as on date..
