With reference to letter cited above, this is to submit compliance report as below of the conditions stipulated therein for favour of your information and necessary action:

2	Compensatory afforestation shall be taken up by the Forest Department over 9.90 ha degraded forest land identified at Amortala RF of Amortala Range, under Khellong Forest Division, at the cost of user agency. As far as possible a mixture of local indigenous species shall be planted and monoculture of any species may be avoided.	Noted.
3	The Cost of compensatory afforestation at the prevailing wage rates as per compensatory afforestation scheme and dwarf species plantation shall be deposited in the Compensatory Afforestation fund of Arunachal Pradesh State managed by the Ad-hoc CAMPA, through E-portal in the account of the Ad-hoc CAMPA. The CA will be maintained for 10 years. The scheme may include appropriate provision for anticipated cost increase for works scheduled for subsequent years.
