In inviting a kind reference to the above cited memo no. on the captioned subject and in view of the instruction issued by the Conservator of Forests (Nodal), O/o. the Principal Chief Conservator of Forests, Odisha in his memo No.69 dated. 02.01.2024, you are requested to deposit an amount of **Rs. 29,03,600/-** (Rupees Twenty Nine lakh Three thousand Six hundred) only towards C.A. scheme cost over an area of 1.416 Ha. of Non-forest land identified in village Rukunibori under Muniguda Tahasil of Rayagada District/Division through online web portal of MoEF & CC and submit the deposit particulars of the amount paid in the prescribed CAMPA format to this office for taking further action at this end.

Besides the above, you are requested to deposit **Rs. 14,10,421/-** (Rupees Fourteen lakh Ten Thousand Four Hundred Twenty One) only towards NPV for 1.148 Ha. of area @ **Rs.12,28,590/-** per hectare being the diverted land coming under Eco-value - Class III (Dance forest with canopy 0.4) through online web portal of MoEF & CC (CAMPA Account) within 30 days of receipt of this letter. The RTGS receipt along with the UTR number in support of the above payment may please be submitted to this office for taking further action at this end. Further you are also requested to furnish an undertaking to pay the additional amount of NPV if so, determined by the Govt. of India/ State Govt. in future.

You are also requested to furnish the required compliance as stipulated in conditions imposed by GoI, MoEF & CC, Regional Office, Bhubaneswar in their 'Stage-I/in-principle' approval order No. 5-ORB601/2023-BHU dt.20.12.2023 to this office for onward transmission to the Principal Chief Conservator of Forests (Forest Diversion & Nodal Officer, FC Act), O/o. the Pr. CCF, Odisha through the Regional Chief Conservator of Forests, Koraput Circle, Koraput.
