Adverting to the subject and reference cited above, it is informed that. Prl. Chief Conservator of Forests. (HoFF). TS. Hyderabad communicated the Stage-I approval for diversion of 0.0989 Ha (21 Guntas) of forest land in compartment No.14 of Sulthanpur RF of Mattampalli Village and Mandla of Suryapet Division and District in favour of NCL Industries from factory main gate wall to outside of the factory. And further instructions were issued to submit the demand notice for vetting to the Nodal Officer, Aranaya Bhavan, Hyderabad and then issue same to the User Agency for making payment of compensatory levies.

In view of the above, as per the conditions stipulated in the Stage-I, the Demand Notice is prepared as follows:

The User Agency is requested to deposit the compensatory levies towards CA, NPV etc. into the Telangana State Compensatory Afforestation Fund Management and Planning Authority (CAMPA) saving bank Account, through online mode only, through e-portal method at MoEF&CC, GOI, New Delhi portal i.e., http://parivesh.nic.in by generating the challan in consultation with Nodal Officer, Telangana State Forest Department. The user agency needs to upload the demand notice against the project for approval by Nodal Officer (FCA). Telangana and generate challan after approval. The payment to be made against the Challan number and the Challan is valid for one week. A step-by-step process is available at http://parivesh.nic.in.

Further. User Agency is requested to comply with following in accordance with the MoEF&CC. Gol instructions issued vide F.no.7-23-2012-FC. Dt.24.07.2013 communicated vide Prt. Chief Conservator of Forests, A.P. Hyderabad Rc.No.45921/2001/F4. Dt.23.08.2013:

- 1. Publish the entire Forest clearances granted in verbatim along with the condition and safe-guards imposed by the Central government in two widely circulated daily newspaper one is vernacular language and the other in English granted to the project proponent for the use of forest land for the non-forest purposes.
- 2. The copies of the Forest clearance should also be submitted to the heads of local bodies. Panchayats and Municipal bodies by the project proponents in addition to the relevant offices of the Government who in turn has to display the same for 30 days.

The transfer of forest land to User Agency shall not be affected prior to the issue of final (Stage II) approval.

In view of the above the Demand Notice is issued for making necessary payments and further necessary action.
