With reference to the aforementioned letters on the captioned subject, this is to apprise that the condition No. 2.A(ii) of the approval order dated 03.03.2023 of IRO, Govt. of India, MoEF&CC, Bhubaneswar, you are requested to deposit an amount of Rs. 8,07,69,587/-(Rupees Eight core Seven lakh Sixty nine Thousands Five hundred Eighty seven) only towards Penal NPV over 56.22 ha forest land use for non-forestry activities in violation of FC Act, 1980 involved in the aforementioned diversion proposal. The details calculation Penal NPV is furnished below.
