
Sir/Madam,

With reference to the subject cited above on the captioned subject, it is intimate you that the financial out lay for CA Scheme over an area 4.560 ha. of Non-forest land identified in village Sanadhauragotha under Deogarh Forest Division pertaining to the above project amounting to **Rs.23,56,700/- (Rupees Twenty Three Lakhs Fifty Six Thousand Seven Hundred)** only has been technically approved by PCCF (FD & NO, FC Act) at the wage rate of Rs.311/- per man days with 10 years maintenance. This fund was deposited by you vide UTR No. SBIN 818156593425 dt.05.06.2018 & UCBAH 21365311614 through RTGs dt.31.12.2021.

Due to revision of wage rate Rs.311/- MD to Rs.326/- MD the above financial outlay of CA Scheme has been revised and technically approved by Chief Conservator of Forests, (FD & NO, FC Act) O/o the PCCF & HoFF, Odisha, Bhubaneswar vide his Memo No.9887 dt.11.05.2022 for **Rs.42,72,800/- (Rupees Forty-Two Lakhs Seventy-Two Thousand Eight Hundred)** only. The technically approved letter enclosed herewith for information.

Therefore, you are requested to deposit the differential amount of $(Rs.42,72,800.00 - Rs.23,56,700.00) = Rs.19,16,100/-$ (Rupees Nineteen Lakhs Sixteen Thousand One Hundred) only as the differential amount towards the CA for payment through web portal (<http://parivesh.nic.in>) of MoEF & CC and submit the deposit particulars to this office at early date for taking necessary action at this end.
