It is informed that in the reference 1st cited, the Govt. of India has accorded In- Principle (Stage-I) approval for **"Diversion of 4.490 Ha of forest land in Compartment No:127 of Kondaveedu Extn-I RF, Ameenabad Beat, Guntur Range & Division for extraction of Road metal and gravel in favour of M/s. Dara Minerals Mg.partners Sri Dara Appa Rao"** subject to fulfillment of certain conditions.

In the reference 2nd cited, the User Agency has been requested to submit the condition wise compliance report.

In the reference 3rd cited, the District Forest Officer, Ongole has prepared the revised CA scheme over an extent of 3.70 Ha non-forest land identified in Sy.No.1018 to

1022 of Allinagaram Village, Komarolu Mandal of Kanigiri Range for an amount of Rs.63.813 lakhs and submitted to the Chief Conservator Forests, Guntur for administrative approval and the same was approved by the Chief Conservator of Forests, Guntur vide reference 4th cited.

In the reference 5th & 10th cited, this office has prepared the CA schemes over an extent of 1.23 Ha with a financial out lay of Rs. 9.370 lakh towards 1 ½ times to SZA and Rs.4.846 lakhs towards raising of gap planting around the 100 meters from the outer perimeter of the mining lease and submitted to the Chief Conservator of Forests, Guntur. The Chief Conservator of Forests, Guntur vide reference 6th & 11th cited has accorded administrative approval of the CA schemes.

Amount demanded to be deposited in Adhoc CAMPA, through e-payment mode i.e challan generated through the Ministry's web portal (i.e www.parivesh.nic.in) only.

I. (a) Procedure for e- challan generation:

- On issue of this demand notice, the user agency shall login to Forest Clearance portal **forestsclearance.nic.in** to generate e-challan and make payment against the demand.

- ii. Agency shall fill all the details as per the format provided in the portal and submit to Nodal Officer for verification.
- iii. Once it is verified by Nodal Officer, Agency can generate e-challan from the portal.

II. (b) Procedure for Payment through RTGS:

- i. For payment through RTGS, the representative of the agency should visit his bank branch (RTGS enabled) of a Bank of his choice along with printed e-challan with an Account Number printed on it.
- ii. While tendering the e-challan at the bank, the agency must ensure that the unique account number mentioned in the challan should be correctly mentioned as the account number in which funds to be remitted.
- iii. Upon executing the RTGS by the sender/ remitter bank, the amount collected will be credited to relevant CAMPA state account with the Bank on real time basis.
