In the reference 3rd cited, the District Forest Officer, Ongole has prepared the revised CA scheme over an extent of 3.95 Ha non-forest land identified in Sy.No.1019 of Allinagaram Village, Komarolu Mandal of Kanigiri Range to a tune of Rs.56.413 lakhs and submitted to the Chief Conservator Forests, Guntur for administrative approval and the same was approved by the Chief Conservator of Forests, Guntur vide reference 4th cited.

In the reference 5th & 10th cited, this office has prepared the CA schemes over an extent of 1.305 Ha with a financial out lay of Rs. 10.017 lakh towards 1½ times to SZA and Rs.4.846 lakhs towards raising of gap planting around the 100 meters from the outer perimeter of the mining lease and submitted to the Chief Conservator of Forests, Guntur. The Chief Conservator of Forests, Guntur vide reference 6th & 11th cited has accorded administrative approval of the CA schemes.

(a) Procedure for e- challan generation:

 On issue of this demand notice, the user agency shall login to Forest Clearance portal *forestsclearance.nic.in* to generate e-challan and make payment against the demand.

- ii. Agency shall fill all the details as per the format provided in the portal and submit to Nodal Officer for verification.
- iii. Once it is verified by Nodal Officer, Agency can generate e-challan from the portal.

II. (b) Procedure for Payment through RTGS:

- i. For payment through RTGS, the representative of the agency should visit his bank branch (RTGS enabled) of a Bank of his choice along with printed echallan with an Account Number printed on it.
- ii. While tendering the e-challan at the bank, the agency must ensure that the unique account number mentioned in the challan should be correctly mentioned as the account number in which funds to be remitted.
