Subj: Diversion of 0.852 Ha Deemed Forest Land - Re-alignment of pipelines in the new route
 (NH-40), 7th Mile, Upper Shillong.

Sir,


With reference to the subject cited above, I am to inform you that the Government vide letter no FOR.9/2022/59 dated 26/03/2022 has convey its Stage I Approval (Copy enclosed) for the diversion of 0.852 ha of deemed forest land for shifting of PHE utilities due to improvement/ widening to 2 lane with paved shoulder/ 4 lane of NH-40 between Shillong – Dawki road section upto Bangladesh Border including Dawki Bridge in the State of Meghalaya.

In this regard I would like to request you to comply with the following conditions:-

1. As per point 3 & 4 of the Stage I approval, you shall pay the cost of raising Compensatory Afforestation amount to **Rs 15,77,520/- (Rupees Fifteen Lakhs Seventy Seven Thousand Five Hundred twenty only)** and Net Present value (NPV) of **Rs 11, 01,508/- (Rupees Eleven Lakhs One Thousand Five Hundred and Eight only)** respectively by transferring / depositing into the CAMPA fund through e-portal (<https://parivesh.nic.in/>).
2. As per point no 8 & 9 of the Stage I approval, you shall transfer the cost of demarcation pillars of 76 numbers amounting to **Rs 4,70,800/- (Rupees Four Lakhs Seventy Thousand Eight Hundred only)** and also cost of tree felling amounting to **Rs 40,000/- (Rupees Forty Thousand only)** respectively by cheque into the current A/c of The Divisional Forest Officer, East Khasi Hills & Ri-Bhoi (T) Division, Shillong, **A/c No.30852745780**.
3. Also, I am to instruct you to issue Compliance Report on all the conditions laid down in the Stage-I approval.
