विषयः साउथ ईस्ट यूपी पॉवर ट्रांसिमशन लि0 द्वारा 765के0वी0 सिंगल सिंकट मैनपुरी—उन्नाव पारेषण लाइन के निर्माण हेतु मैनपुरी में प्रभावित 1.5364 हे0 संरक्षित वनभूमि के गैरवानिकी प्रयोग व 238 वृक्षों के पातन, कन्नौज में प्रभावित 0.32 हे0 संरक्षित वनभूमि के गैरवानिकी प्रयोग व 8 वृक्षों के पातन, कानपुर में प्रभावित 0.8155 हे0 संरक्षित एवं 3.5583 हे0 आरिक्षत वनभूमि के गैरवानिकी प्रयोग व 398 वृक्षों के पातन तथा उन्नाव में प्रभावित 0.6813 हे0 संरक्षित एवं 8.7003 हे0 आरिक्षत वनभूमि के गैरवानिकी प्रयोग व 1502 वृक्षों के पातन अर्थात 3.3532 हे0 संरक्षित एवं 12.2586 हे0 आरिक्षत वनभूमि कुल 15.6118 हे0 वनभूमि के गैरवानिकी प्रयोग एवं बाधक 2146 वृक्षों के पातन की अनुमित के सम्बन्ध में।

कृपया उपरोक्त विषयक सचिव (वन), उत्तर प्रदेश शासन के पत्रांक पी–101/81–2–2025–800(95)/2025, दिनांक 04.06.2025 का आशय ग्रहण करने का कष्ट करें, जिसके द्वारा विषयांकित प्रकरण में राज्य सरकार द्वारा वन (संरक्षण एवं संवर्धन) अधिनियम, 1980 के अन्तर्गत भारत सरकार की स्वीकृति मांगी गयी थी।

प्रकरण को दिनांक 26.08.2025 को आहूत की गई क्षेत्रीय सशक्त समिति (REC) की बैठक में (REC Agenda item 6.3-UP) शामिल किया गया था। क्षेत्रीय सशक्त समिति के निर्णायानुसार प्रकरण में स्वीकृति प्रदान की गयी है। प्रकरण में विचारोपरान्त मुझे आपको यह सूचित करने का निर्देश हुआ है कि केन्द्र सरकार साउथ ईस्ट यूपी पॉवर ट्रांसमिशन लि0 द्वारा 765के0वी0 सिंगल सर्किट मैनपुरी—उन्नाव पारेषण लाइन के निर्माण हेतु मैनपुरी में प्रभावित 1.5364 हे0 संरक्षित वनभूमि के गैरवानिकी प्रयोग व 238 वृक्षों के पातन, कन्नौज में प्रभावित 0.32 हे0 संरक्षित वनभूमि के गैरवानिकी प्रयोग व 8 वृक्षों के पातन, कानपुर में प्रभावित 0.8155 हे0 संरक्षित एवं 3.5583 हे0 आरक्षित वनभूमि के गैरवानिकी प्रयोग व 398 वृक्षों के पातन तथा उन्नाव में प्रभावित 0.6813 हे0 संरक्षित एवं 8.7003 हे0 आरक्षित वनभूमि के गैरवानिकी प्रयोग व 1502 वृक्षों के पातन अर्थात 3.3532 हे0 संरक्षित एवं 12.2586 हे0 आरक्षित वनभूमि कुल 15.6118 हे0 वनभूमि के गैरवानिकी प्रयोग एवं बाधक 2146 वृक्षों के पातन की सैद्धांतिक स्वीकृति निम्नलिखित शर्तों पर प्रदान करती है:—

- 1. Legal status of the forest land shall remain unchanged.
- 2. Compensatory afforestation shall be taken up by the Forest Department in an area of 31.2236 ha. Degraded Forest Land (DFL) at the cost of the user agency. As far as practicable a mixture of local indigenous species will be planted and monoculture of a species has to be avoided. The details of CA are as follows:-

- 3. The cost of compensatory afforestation at the prevailing wage rates as per compensatory afforestation scheme and the cost of survey, demarcation and erection of permanent pillars if required on the CA land shall be deposited in advance with the Forest Department by the project authority. The CA will be maintained for 10 years. The scheme will be for plantation and may include appropriate provision for anticipated cost increase for works scheduled for subsequent years.
- 4. The State Government shall charge the Net Present Value (NPV) for the **15.6118** ha. forest area to be diverted under this proposal from the User Agency as per the orders of the Hon'ble Supreme Court of India dated 30/10/2002, 01/08/2003, 28/03/2008, 24/04/2008 and 09/05/2008 in IA No. 566 in WP (C) No. 202/1995 and as per the guidelines issued by the Ministry vide letters No. 5-1/1998-FC (Pt.II) dated 18/09/2003, as well as letter No. 5-2/2006-FC dated 03/10/2006, 5-3/2007-FC dated 05/02/2009 and letter No.5-3/2011-FC(Vol-I) dated 6/1/2022 in this regard.

- 5. Additional amount of the NPV of the diverted forest land, if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert Committee, shall be charged by the State Government from the User Agency. The User Agency shall furnish an undertaking to this effect.
- 6. User agency shall restrict the felling of trees to 2146 trees/minimum number in the diverted forest land and the trees shall be felled under the strict supervision of the State Forest Department and the cost of felling of trees shall be deposited by the User Agency with the State Forest Department.
- The FRA certificate as per Ministry's guidelines shall be submitted before the issuance of final approval.
 The complete compliance of the FRA, 2006 shall be ensured by way of prescribed certificate from the concerned District Collector.
- 8. No violation of Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 certificate from concerned DFO shall be provided.
- 9. The User agency in consultation with the State Forest Department prepare a detailed scheme for creation and maintenance of plantation of dwarf species in right of way under the transmission line and deposit the cost for execution of the said scheme to the State Forest Department.
- 10. The user agency at its cost shall provide bird deflectors, which are to be fixed on upper conductor of transmission line at suitable intervals to avoid bird hits.
- 11. The User Agency shall comply with the guidelines for laying transmission lines through forest areas issued by Ministry vide dated 29.12.2023.
- 12. User Agency shall obtain Environmental Clearance as per the provisions of the Environmental (Protection) Act, 1986, if applicable.
- 13. Width of right of way for the transmission line shall be limited to specified length in meter.
- 14. The user agency shall install circuit breakers at suitable places besides maintain necessary ground clearance to prevent electrocution of wild animals.
- 15. No approach road shall be constructed in the forest area for transportation of steel and other material required for the transmission line. As far as possible the User Agency shall use the existing road and the proposed RoW for the transportation of the material and in the event of non-availability of such facilities, the User Agency shall transport material manually without construction of any path.
- 16. The layout plan of the proposal shall not be changed without prior approval of Central Government.
- 17. No labour camp shall be established on the forest land.
- 18. The User Agency shall provide fuels preferably alternate fuels to the labourers and the staff working at the site so as to avoid any damage and pressure on the nearby forest areas.
- 19. The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost, as per the directions of the concerned Divisional Forest Officer.
- 20. No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work.
- 21. The proposed Degraded Forest Land (DFL) for CA land shall be adequately fenced for complete protection using the chain link fencing at the cost of the User agency.
- 22. Solar-powered pumps with borewell shall be installed at the CA (compensatory afforestation) site for irrigation purposes to ensure better survival of plants at the cost of User Agency.
- 23. The period of diversion under this approval shall be for 40 years or co-terminus with the period of the project life, whichever is earlier.
- 24. The State Government shall ensure necessary action subsequent to any change in forest area/forest boundary after completion of digitization.
- 25. DFO needs to certify that the area proposed for diversion is as per the existing Working Plan and no other affected forest area is left to be included in the proposal.
- 26. The forest land shall not be used for any purpose other than that specified in the project proposal.
- 27. The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval of Govt. of India.
- 28. The KML file of area proposed for diversion and area proposed for plantation shall be uploaded on the E-Green watch portal with all requisite details before commencement of works.

- 29. Any order of Temporary Work Permission in case of linear projects for tree cutting and commencement of work as per clause 11.1 of Van (Sanrakshan Evam Samvardhan) Adhiniyam Guidelines shall be passed under intimation to Nodal office and this office. Order of Temporary Work Permission have to be uploaded on PARIVESH Portal as well. Nodal Officer will strictly monitor and ensure that no further activity is carried out under such permission after the expiry of one year from the date of issue of such permission.
- 30. Violation of any of these conditions will amount to violation of Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 and action would be taken as per para 1.16 of consolidated guideline and clarifications on Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 and Van (Sanrakshan Evam Samvardhan) Rules, 2023, MoEF&CC.
- 31. Any other condition that the Ministry of Environment, Forests & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forests & wildlife.
- 32. This approval is subject to the final outcome with respect to Hon'ble Supreme Court Orders in the CWP (C) No 1164/2023 dated 3.2.2025 and 4.3.2025.
- 33. All the funds received from the user agency under the project shall be transferred/ deposited to CAMPA fund only through *e-portal* (https://parivesh.nic.in/).
- 34. The compliance report shall be uploaded on *e-portal* (<u>https://parivesh.nic.in/</u>).

After receipt of the compliance report on the fulfillment of the conditions mentioned above, the proposal shall be considered for final approval under section 2 of the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980. Transfer of forest land shall not be effected till final approval is granted by the Government in this regard.
