Sub: Final (Stage-II) approval of Central Government under Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 for proposed diversion of 1.2401 ha forest land in favour of PWD Jaipur for development of Arain-Sarwad Highway, Section of SH-7E, from existing Km 44.300 to Km 0.000, Ajmer District in the State of Rajasthan- reg.

सन्दर्भः शासन सचिव का पत्र क्रमांक प.1(41)वन/2023 दिनांक 09.02.2024. महोदय,

उपरोक्त विषयक शासन सचिव, वन विभाग, राजस्थान सरकार, जयपुर के पत्रांक प.1(41)वन/2023 दिनांक 20.06.2023 का आशय ग्रहण करने का कष्ट करें जिसके माध्यम से राज्य सरकार द्वारा विषयांकित प्रस्ताव पर केन्द्र सरकार से वन (संरक्षण एवं संवर्धन) अधिनियम, 1980 की धारा-2 के तहत् स्वीकृति मांगी गयी थी।

प्रश्नगत प्रकरण में इस कार्यालय के समसंख्यक पत्र दिनांक 13.09.2023 द्वारा सैद्धांतिक स्वीकृति प्रदान की गयी थी जिसकी अनुपालना उपरोक्त संदर्भित पत्र द्वारा प्रेषित की गयी है। प्रस्तुत अनुपालना के अवलोकन पश्चात्, केन्द्र सरकार उपरोक्त विषयांकित परियोजना हेतु 1.2401 हेक्टेयर वनभूमि के प्रत्यावर्तन एवं 01 वृक्ष के पातन की विधिवत् स्वीकृति (Final/Stage-II Approval) निम्नलिखित शर्तों पर प्रदान करती है:-

- 1. Legal status of the forest land shall remain unchanged.
- 2. Compensatory afforestation shall be taken up by the Forest Department over 1.25 ha non-forest land, Khasra No. 821/754, Village- Sawaipura, Tehsil-Pisangan, District- Ajmer of Rajasthan at the cost of the user agency. As far as possible, a mixture of local native species shall be planted and monoculture of any species, especially non-native species should be avoided.
- 3. User Agency shall restrict the felling of trees to 01 trees/ minimum numbers in the diverted forest land and the trees shall be felled under the strict supervision of the State Forest Department and cost of felling of trees shall be deposited by the User Agency with the State Forest Department.
- The User Agency shall raise strip plantation on both sides and central verge of the road as per the IRC norms.
- 5. Speed regulating signage will be erected along the road at regular intervals in the Protected Areas/ Forest Areas.
- 6. The User Agency shall construct underpass 2-3 meter height at every 500 meter along the length of the road in forest land for safe passage of the animals.

- The User Agency shall construct 6 feet high wall along the boundaries of the non-forest land proposed for CA.
- 8. User Agency shall provide at its cost required number of Solar Pumps as given by the Forest Department for irrigating the CA plantation.
- 9. The layout plan of the proposal shall not be changed without prior approval of Central Government.
- 10. No labour camp shall be established on the forest land.
- 11. Sufficient firewood, preferably the alternate fuel, shall be provided by the User Agency to the labourer after purchasing the same from the State Forest Department or the Forest Development Corporation or any other legal source of alternate fuel.
- The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost, as per the directions of the concerned Divisional Forest Officer.
- 13. No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work.
- 14. The period of diversion under this approval shall be co-terminus with the period of lease to be granted in favour of the user agency or the project life, whichever is less.
- 15. The forest land shall not be used for any purpose other than that specified in the project proposal.
- 16. The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval of Govt. of India.
- 17. The User Agency shall submit the annual self compliance report in respect of the above stated conditions to the State Government and Regional Office, Gandhinagar by the end of March every year.
- The User Agency shall comply with all the provisions of the all Acts, Rules, Regulations, Guidelines, Hon'ble Court Order (s) and NGT Order (s) pertaining to this project, if any, for the time being in force, as applicable to the project.
- 19. All the conditions of Stage-I approval shall be strictly complied.
- 20. Violation of any of these conditions will amount to violation of Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 and action would be taken as per the MoEF&CC Guideline F. No. 11-42/2017-FC dt 29/01/2018.
- 21. Any other condition that the Ministry of Environment, Forests & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forests & wildlife.
