The Government of India vide Ref (1) have accorded 'in-principle' (Stage-I) approval for diversion of 32.28 hectare of forest land in Devasamudra and 9 other villages in Chitradurga District for strengthening and widening of 159.9 km long stretch of

existing National Highway (NH-150A) from Ballari (KM 253.600) to Hiriyur (KM 413.500) in favour of the Deputy General Manager, National Highway Authority of India, Project Implementing Unit, Hosapete subject to fulfillment of certain conditions stipulated therein.

Based on Stage-I approval from the Central Government, the Government of Karnataka vide Ref (2) has also sought the compliance report on the conditions of Stage-I approval.

Accordingly, this office vide Ref (3) informed the User Agency and field officers to submit the Compliance Report in respect of the conditions of Stage-I approval.

In response, the User Agency vide Ref (4) has submitted the Compliance Report to the Deputy Conservator of Forests, Chitradurga Division, who after field verification has vide Ref (5) submitted the condition wise compliance to the Chief Conservator of Forests, Ballari Circle, and the same has been submitted to this office vide Ref (6).
