SCHEME FOR CREATION AND MAINTENANCE OF ALTERNATE HABITAT/HOME FOR THE AVIFAUNA, WHOSE NESTING TREES ARE TO BE CLEARED COVERED IN 4.828 Ha.OF FOREST LAND REQUIRED FOR MAN WINDING SHAFT IN SHANTHIKHANI LONG WALL PROJECT IN MANDAMARRI AREA.

As per the condition No.(xv) of Stage-I Clearance communicated vide MoEF Lr.No. No.8-87/2001-FC (vol.i), dtd.08.01.2019 the user agency in consultation with the State Forest Department shall create and maintain alternative habitat/home for the avifauna whose nesting trees are to be cleared in this project. Bird's nests artificially made out of eco-friendly materials shall be used in the area, including forest area and human settlements adjoining the forest area being diverted for the project. Accordingly, a plan has been prepared for providing alternative nesting sites for the avi-fauna.

The birds normally seen in this area are common myna (Acridotherestristis) Greater coucal (Centropussinessis), Blue rock pigeon (Columbislivia), Black drongo (Edolius macrocercous), Small bee cater (meropsorientalis), White wagtail (Motocilla alba), House sparrow (passer domesticus) etc.,

- Due to disturbance of the area in the process of mining, these birds forego their nesting habital. Even if the habitats are not directly removed by the excavation, they can be indirectly affected and damaged by environmental impacts-such as changes to ground water or surface water that causes some habitats to dry out or others to become flooded. Even noise pollution can have a significant impact on some species and affect their successful reproduction.
- Hence the need for providing alternative habitat by means of planting of tree species and keeping artificial nesting structures is proposed.
- Trees that attract birds species like Bombox, various Ficus species Embica
 officinalis, Aegle marmelos and Inga dulce will be planted in around the project area in
 more numbers as flowers and fruits of these species are liked by birds.
- To attract these birds, nest boxes of various sizes will be installed, about 100 nest boxes of different sizes and types in the surrounding areas of the project area so that their effectiveness in attracting the birds will be studied and if they are proved to be useful some more boxes will be installed in the next phase.
- Approximate cost of the 100 nest boxes would be Rs.1.00 lakhs.
