
(UNQUALIFIED COMMITMENT FROM THE PROJECT OFFICIAL AS PER THE TERMS AND CONDITIONS OF IN-PRINCIPLE APPROVAL ACCORDED BY MINISTRY OF ENVIRONMENT, FOREST AND CLIMATE CHANGE, INTEGRATED REGIONAL OFFICE, JAMMU)

It is to state that the National Highways & Infrastructure Development Corporation Limited, who is the Project Authority for the diversion of Diversion of 5.146 ha of forest land for Additional ROW requirement for development of two bridges located at Km- 2+250 to Km- 10+560 of Chenani - Sudhmahadev road (NH- 244), District Udhampur, U.T. of Jammu & Kashmir hereby agree on the below mentioned points as per the Terms and Conditions of Ministry of Environment, Forest and Climate Change, Integrated Regional Office, Jammu vide File No: 9-JKC-18/2021-Jammu; Dated: 21-06-2021. The points are:

1. Legal status of the forest land will remain unchanged.
2. Efforts should be made to fell minimum number of trees and in any case, not more than 331 trees & 477 plants will be felled.
3. The acquired dumping sites should be prepared appropriately before start of dumping to prevent downhill slide of muck.
4. Angle of repose of muck should be maintained between 30° to 40°.
5. Long slope should be intercepted to several short ones with help of berms/terraces/bermiles.
6. Dumping sites which have attained full capacity should be rehabilitated with local grass, trees and shrubs.
7. The forest land will not be used for any other purpose than that mentioned in the proposal.
8. The forest land proposed to be diverted shall under no circumstances be transferred to any other agency, department or person without approval of the Central Government.
9. The layout plan of the proposal shall not be changed without the prior approval of the Central Government.
10. No damage will be done to the adjoining forest land.
11. No labour camp shall be established on the forest land.



12. The user agency shall pay additional amount of NPV as and when increased on the order of Hon'ble Supreme Court.
13. The user agency shall provide firewood preferably alternate fuels to the labourers and the staff working at the site so as to avoid any damage and pressure on the nearby forest areas.
14. Any other condition that this Regional Office may stipulate, from time to time, in the interest of conservation, protection and development of forests & wildlife.
