Kind attention is invited to the references cited.

It is submitted that the Government vide reference 6<sup>th</sup> cited has conveyed Central Government **in-principle (Stage-I) approval** under Section 2 of Forest (Conservation) Act, 1980, for diversion of forest land to an extent of **2.325 Ha (Mahadevpur Division 1.298 Ha + Bhupalpally Division 1.027 Ha)** under Jayashankar-Bhupalpally District, in favour of Superintending Engineer, TDWSP Circle, Karimnagar, for laying of pipe line and construction of structures for **Segment-15/3 (Mahamutharam)**, for providing drinking water under Telangana Drinking Water Supply Project. The above orders have been communicated to all the concerned officers with instructions to submit condition-wise compliance report in the matter, vide reference 7<sup>th</sup> cited.

Accordingly, the District Forest Officer, Jayashanker-Bhupalpally/Forest Divisional Officers, Mahadevepur & Bhupalpally have obtained compliance of conditions from the User Agency and submitted the condition-wise compliance report together with its enclosures through CCF/Conservator of Forests, Warangal, which is received in this office through vide reference 8<sup>th</sup> cited. A copy of reference 8<sup>th</sup> cited together with its enclosures is enclosed herewith **in duplicate**.
