It is submitted that the Government vide reference 6th cited has conveyed Central Government **in-principle** (Stage-I) approval under Section 2 of Forest (Conservation) Act, 1980, for diversion of forest land to an extent of 2.325 Ha (Mahadevpur Division 1.298 Ha + Bhupalpally Division 1.027 Ha) under Jayashankar-Bhupalpally District, in favour of Superintending Engineer, TDWSP Circle, Karimnagar, for laying of pipe line and construction of structures for Segment-15/3 (Mahamutharam), for providing drinking water under Telangana Drinking Water Supply Project. The above orders have been communicated to all the concerned officers with instructions to submit condition-wise compliance report in the matter, vide reference 7th cited.

Accordingly, the District Forest Officer, Jayashanker-Bhupalpally/Forest Divisional Officers, Mahadevepur & Bhupalpally have obtained compliance of conditions from the User Agency and submitted the condition-wise compliance report together with its enclosures through CCF/Conservator of Forests, Warangal, which is received in this office through vide reference 8th cited. A copy of reference 8th cited together with its enclosures is enclosed herewith **in duplicate**.

The condition-wise compliance report is reproduced with remarks as follows:-
