viii.	The user agency shall seek permission from Forest Department, Dadra & Nagar Haveli for carrying out maintenance.	Agreed by the User Agency
ix.	The User agency shall be responsible for any loss to the flora/fauna in the surroundings and therefore, shall take all possible measures to conserve the same.	Agreed by the User Agency The best possible and strict measures shall be taken to conserve the flora/fauna during construction.
x.	The User Agency shall obtain the Environmental Clearance before the formal order, if applicable.	Not Applicable as stated by the User Agency
xi.	All statutory provisions under various acts, Rule there under and guidelines applicable to this project shall be strictly adhereto.	Agreed by the User Agency
xii.	All the funds received from the user agency under the project shall be transferred / deposited to CAMPA fund only through e.portal ( <a href="http://forestsclearance.nic.in">http://forestsclearance.nic.in</a> ) .
