May kindly peruse the letter No. GGL/DNH GA/FCA/0.5029 Ha/Formal Approval/2020 dated 27.10.2020 regarding proposal for diversion of 0.5029 Ha. of protected Forest land for laying of 8" mm. dia. Steel Natural Gas pipeline by Gujarat Gas Limited for Samarvarni, Saily, Athol and Khanvel villages in the U.T. of Dadra & Nagar Haveli, Silvassa.

8	The User agency shall seek permission from local Forest Department for carrying out any maintenance;	Agreed by U.A.
9	The User agency shall be responsible for any loss to the flora / fauna in the surroundings and therefore, shall take all possible measures to conserve the same.	Agreed by U.A.
10	All statutory provisions under various Acts, Rule there under and guidelines applicable to this project shall be strictly adhered to.	Agreed by U.A.
11	It will be the responsibility of the User Agency to ensure that the labourers and staff engaged in construction activity do not damage forest flora and fauna	Agreed by U.A.
12	The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval of Central Government	Agreed by U.A.
