Bhilosa Industries Connectivity in village Kharadpada in the U.T. of Dadra & Nagar Haveli, Silvassa.

1	The legal status of the forest land shall remain unchanged i.e. shall remain Reserve / Protected / Village / other types of forests / forest as the case may be.	Agreed by U.A.

3	The maximum size of the trench shall not be more than 2.00 meter depth and 1.00 meter width.	Agreed by U.A.

6	The User agency shall pay the Net Present Value (NPV) of the diverted forest land at the rates stipulated by the Ministry of Environment and Forests from time to time.	Agreed by U.A.
7	Additional amount of the NPV of the diverted forest land if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert committee, shall be charged by the State Government from the User Agency. The User Agency shall furnish an undertaking to this effect.	The undertaking has been submitted by the U.A. For depositing the Additional NPV after finalization of same by the Hon'ble Supreme Court may please be seen at page C/85.
8	The User agency shall seek permission from local Forest Department for carrying out any maintenance;	Agreed by U.A.
9	The User agency shall be responsible for any loss to the flora / fauna in the surroundings and therefore, shall take all possible measures to conserve the same.	Agreed by U.A.

10	All statutory provisions under various Acts, Rule there under and guidelines applicable to this project shall be strictly adhered to.	Agreed by U.A.
11	It will be the responsibility of the User Agency to ensure that the labourers and staff engaged in construction activity do not damage forest flora and fauna	Agreed by U.A.
12	The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval of Central Government	Agreed by U.A.
13	Proposed labour camps outside the forest area to be dismantled and removed. The labourers shall be sent back immediately after the completion of work.	Agreed by U.A.
14	The User Agency shall transfer / deposit ₹ 4,68,425/- (Rupees : Four Lakh Sixty Eight Thousand Four Hundred Twenty Five only) towards Compensatory Afforestation including maintenance for 10 years and ₹ 3,03,297/- (Rupees : Three Lakh Three Thousand Two Hundred Ninety Seven only)	The Payment is transferred by to Ad-hoc CAMPA vide transaction NEFT / RTGS No. N044201063856161 dated 13.02.2020 may please be seen at page C/85.
15	All the fund received from the User Agency under the project shall be transferred to the CAMPA fund only through e.portal (http://www.parivesh.nic.in). 16	The forest land shall not be used for any purpose other than that specified in the proposal.	Agreed by U.A.
