With reference to the above subject, please find here with submitting the compliance report for stage-1 clearance conditions as per the MOEF letter cited under ref-1 pertaining to diversion of 5.237 Ha of forest land in Sy.No 92,156,157& 159 of Marashettyhalli Village, Gubbi Taluk for construction of 110kV D/C narrow based towers for shifting of existing 110kV Nittur-Doddaguni line at HAL factory is depicted here under.

1	The legal status of forest land shall remain unchanged.	The legal status of forest will not be changed
2	The demarcation of the forest area being diverted shall be carried out by erecting cement concrete pillars duly numbered at an interval of 20mts at the cost of user agency, before stage-2 approval.	The work of demarcation of the forest area being diverted is completed. Copy of DGPS coordinates in demarcated forest area is enclosed.
3	The cost of raising compensatory afforestation over double the degraded forest land over an extent of 10.474 ha in Sy.No.110 of Hoovinakatte Village, Chelur Hobli, Gubbi Taluk, Tumakuru District shall be realized from the user agency.	As per the demand notice raised by your office vide ref-2 for an amount of Rs.28,48,928/- for compensatory afforestation is paid to Karnataka Campa, forest department. Further the payment towards demand notice raised vide letter cited under ref-3 will be made shortly.
4	The state govt shall charge the net present value of the diverted forest land of 5.237 ha from the user agency as per the orders of the Hon'ble Supreme court dated 28.03.2008 and 09.05.2008 in IA No's 826 in 566 with related IA's in writ petition (Civil) no.202/1995.	As per the demand notice raised by your office vide ref-2 for an amount of Rs.32,78,362/- for Net Present Value is paid to Karnataka Campa, forest department. Copy of the payment details is enclosed
5	Additional amount of the net present value (NPV) of the diverted forest land if any, becoming due after revision of the same by the Hon'ble Supreme Court of India in future, shall be charged by the state govt. from the user agency. The user agency shall furnish an undertaking to this effect.	Additional amount of Net Present Value of diverted forest land if any will be paid.

6	User agency should ensure that compensatory levies are deposited through challan generated online on the web portal and deposited in appropriate bank online only. Amount deposited through other mode will not be accepted as compliance of the stage-1 clearance.	The amount is deposited through RTGS for the challan generated online on the web portal. Copy of the payment details is enclosed.
7	Necessary certificates/documents under the scheduled tribes and other traditional forest dwellers (Recognition of forest rights) Act-2006 as per the guidelines issued by MOEF vide letter no. 11-9/1998-FC (Pt) dated 05.07.2013 shall be furnished before stage-2 clearance.	The letter dated 31.03.2018 was addressed to Deputy Commissioner, Tumakuru requesting to issue forest right certificate at the earliest. Copy of the letter enclosed.
8	Existing plantations in the Right of way under the transmission line shall be maintained at the cost of user agency and dwarf species needs to be planted wherever possible.	The demand notice is not received from your office and the same will be paid after the receipt of the demand notice.
9	Guidelines issued by the ministry vide letter no. 7-25/2012-FC dated 05.05.2014 for laying of transmission lines through forest area shall be strictly followed.	Guidelines issued by the ministry vide letter no. 7-25/2012-FC dated 05.05.2014 for laying of transmission lines through forest area will be followed.
10	The total forest area utilized for the project shall not exceed 5.237 ha.	The total forest area utilized for the project will not exceed 5.237 ha.
11	Any other condition that the Addl. P.C.C.F (Central), regional office, Bengaluru may impose from time to time for protection, improvement of flora and fauna in the forest area and public convenience, shall also be applicable.	Any other conditions imposed by the Addl. P.C.C.F (Central), regional office, Bengaluru from time to time for protection, improvement of flora and fauna in the forest area and public convenience, will be attended.
12	Violation of any of the conditions shall invite penal action, as deemed fit by the Additional Principal Chief Conservator of Forests (Central), Regional office, Bengaluru.	Conditions will not be violated.
