The proposal is for diversion of 0.99 ha of Protected Forest land for construction of Eco-Park at village Khed Makta, Tal. Bramhapuri, District. Chandrapur. The details of land proposed for diversion is as under-

The project has been initiated by the Deputy Conservator of Forests, Bramhapuri Forest Division, Bramhapuri for seeking approval under Forest (Conservation) Act, 1980. The proposal for diversion of 0.99 ha forest land consists of the requirement of forest land for construction of Gathering Space + Sculptures Court+ Admin+ Museum, Food Court + Research Lab/Interpretation Center, Musical Fountain with stepped seating, Produce market/ Crafts village + Tube well and over head, Electrification + Toilet bath, Information centre + Art roof + Ticket center, Children park, play

area, Service Block + Sculptures landscaping and Walkway (Road) in accordance with Government of Maharashtra, Industry, Energy and Labour Department Resolution No. MDF-0116/C.N.09/Industry-9 dated 15.3.2016.

The Bramhapuri Taluka is mostly surrounded by forest area and at present non forest land is not available. Therefore, there is no Wildlife, Nature Interpretation Center and Eco-Park in the surrounding area. Hence, the proposed Eco- park will act as a live ecological and environmental learning center in the vicinity of the forest land and will also help the visitors to understand about the PTG- Kolam Tribes who are integral part of Chandrapur rich forest. This Eco Park will provide the necessary information to the students and local people and will create awareness regarding forests, wildlife, nature and environment amongst them.

- 2) The area belongs to Eco-value class -III open forest having density of forests 0.1.
- The Deputy Conservator of Forests, Bramhapuri Forest Division, Bramhapuri has stated that no alternate alignment is possible and the forest land required is the barest minimum.
- 4) No cutting and felling of trees is involved in implementation of the project.
- 6) There is no violation of Forest (Conservation) Act 1980 as certified by the Deputy Conservator of Forests, Bramhapuri Forest Division, Bramhapuri.
- 7) The area involved does not form part of any existing National Park, Wildlife Sanctuary, and the Nature Reserve etc. as certified by the Deputy Conservator of Forests, Bramhapuri Forest Division, Bramhapuri.
- 8) The User Agency has submitted an undertaking to defray the cost of Net Present Value of the forest land proposed for diversion.
- 9) The Deputy Conservator of Forests, Bramhapuri Forest Division, Bramhapuri has certified that forest land proposed for construction of Eco-Park at Khed Makta has been demarcated on the spot fixing boundary stone around the area.
- 10) The Deputy Conservator of Forests, Bramhapuri Forest Division, Bramhapuri has certified that the proposed project is not within 10 km from the boundary of the Protected Area.
- The Deputy Conservator of Forests, Bramhapuri Forest Division, Bramhapuri has certified that the proposed area is not likely to affect any monumental site of cultural, historical, religious, archeological or recreational importance.
- The User Agency has submitted the certificate of Collector, Chandrapur under Schedule Tribes and Other Traditional Forest Dweller's (Recognition of Forest Rights) Act 2006 issued vide letter No. Karya-4/RB-II/2017/95,dt.21/08/2017 as per Government of India letter dt.5/7/2013 in prescribed format Form- II alongwith all necessary documents required.

- 13) The User Agency has submitted comprehensive detailed land use plan of the area required for construction purpose approved by Competent Authority.
- 14) No compensatory afforestation is required as there is no felling of trees involved and the proposed forest area is below 1.00 ha.
- 15) Site Inspection Report of the Deputy Conservator of Forests, Bramhapuri Forest Division, Bramhapuri is enclosed in the proposal on page no.140.
- 16) The Chief Conservator of Forest, Chandrapur and the Deputy Conservator of Forests, Bramhapuri Forest Division, Bramhapuri have recommended the proposal for approval.

In view of this, the proposal is recommended for approval under section 2 (ii) of Forest (Conservation) Act, 1980 subject to the following conditions:-

- i. The legal status of the land required will remain unchanged.
- ii. The forest land shall not be used for any purposes other than specified in the project.
- iii. The User Agency will defray the cost of Net Present Value of 0.99 ha. of forest land as per the latest guideline of Government of India.
- iv. The User Agency will defray the additional / revised cost of Net Present Value of forest land as per the latest Guideline of Government of India.
- v. All other conditions as may be mandatory under relevant Acts, Rules and guidelines shall be complied with by the user agency.
