The projects envisage the use of developing of Factory on Assan Kalan- Mor Majra Road (ODR), Near Km. Stone No. 6, Village Khandra, Tehsil Madlauda, Distt. Panipat

1. The site inspection of the land involved in the proposal has been done on dated -24-12-2020
2. On inspection of the site, it is found that the land required by the user agency is a Protected forest measuring **0.01309** hectare to be utilized by user agency and there is three trees effected in the acceleration lane & deceleration lane way of this land.
3. The requirement of forest land as proposed by user agency in Col.2 of part-I is unavoidable and is barest minimum required for the project. The detail of forest area and effected is as under:-

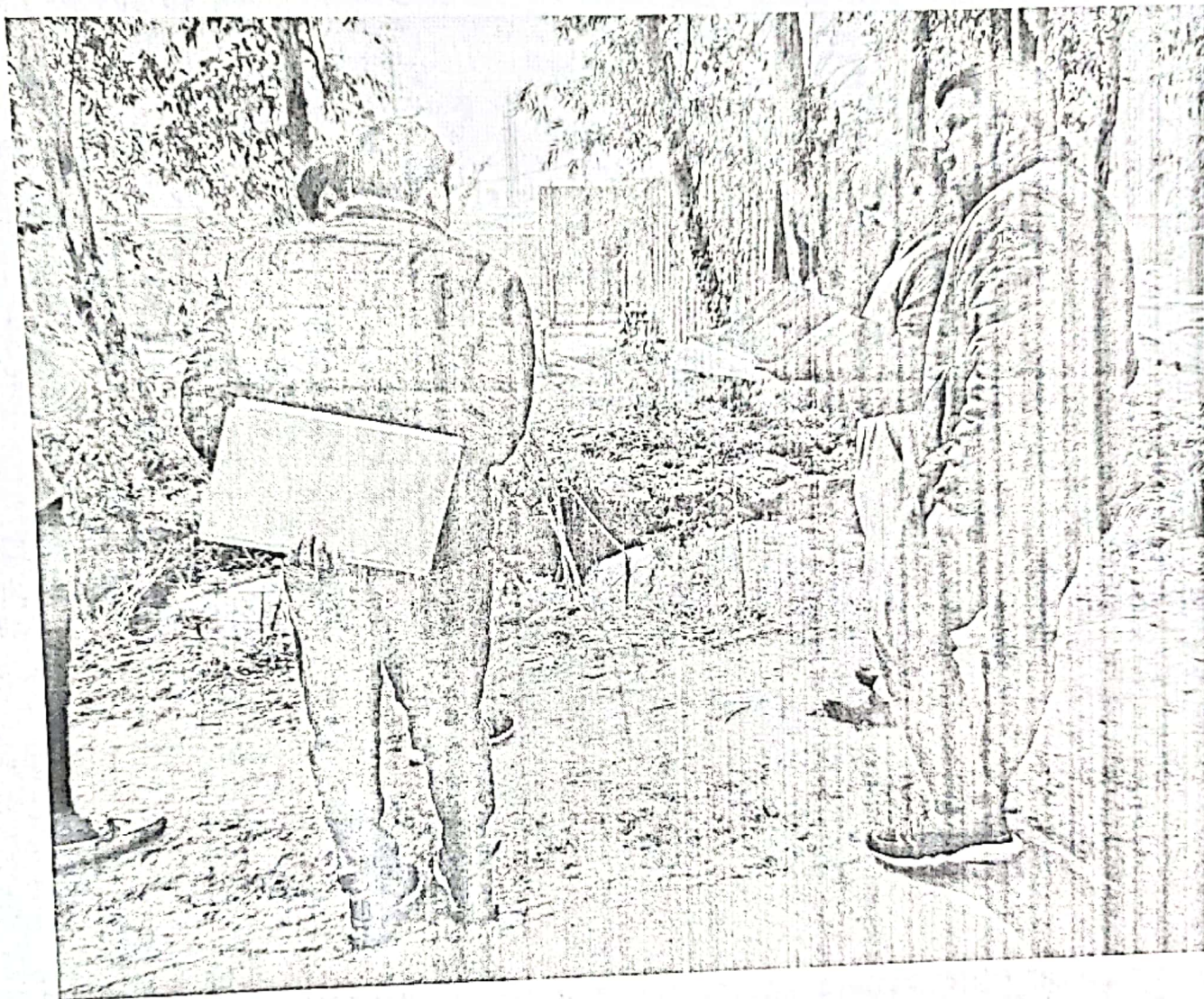
