### Inspection Note:-

The proposed site was inspected by me on 02-06-2021. The factual details regarding the proposed site and consequent findings are stated below:-

- 1- The proposed site is situated under Saran Forest Division, Chapra. The proposal is regarding establishment of HPCL Retail Outlet/Patrol Pump on the approach road of Mashrakh-Gaura Bazar, S.H.-90 Path in Piprahia Mauza. The approach and exit path need diversion of approach road side land. The proposed area is parts of protected forest vide Government of Bihar Notification No. 190 E dated 16-02-1994 and No. 485-E dated 15-04-1994. The total area required for the project is 0.01275 Hac.
- 2- There is no tree present in the proposed area of diversion. The road side plantation has declared as notified forest. There is no rare/endangered/unique species of flora and fauna in this area. No archeological site is present near the proposed site.
- 3- There is no damage to any archeological site or any place of religious or heritage importance.
- 4- The area of proposed diversion of forest land is minimum.
- 5- The user agency has not done any construction on the proposed site.
