Specific recommendations of the DCF for acceptance of otherwise of the proposal with reasons	:	The proposed diversion of Forest area 1859.77 ha spread over five (5) Forest Blocks of Hyderabad Forest Division as mentioned above for development of integrated Eco-Tourism project in Rangareddy district in favour of Telangana State Tourism Development Corporation Lt. Hyderabad is recommended with the following conditions:
1			I) In an event of transfer of the proposed forestland to the TSTDC Ltd, the value of Eucalyptus plantations (for three rotations) should be recovered from the user agency. The proposed diversion area has 415 ha of Eucalyptus plantations, which if not diverted,

would have been harvested for three rotations by the Forest Department.

II) In the areas where the user agency takes up infrastructure development, the cost of extraction of the tree growth should be paid to the Forest Department by the user agency. In this regard, Forest Department will raise demand of the demarcation upon Development area by the user agency. The timber so extracted shall be the property of the Forest Department.

III) The user agency shall clear / fell minimum number of trees for infrastructure development.
