
SITE INSPECTION REPORT

- 1). A proposal of PMGSY Division Thathri is recommended by Divisional Forest Bhaderwah in Parivesh Portal for diversion of Forest land under Forest Conservation Act 1980 for non forestry purpose. The project envisages diversion of 0.38 Hactare of Forest Land at Jourakhurd of Bhaderwah Forest Division in District Doda in favour of PMGSY Division Thathri for Construction of road from Jourakhurd to Shamdlian in Bhaderwah Forest Division.
- 2). No protected/heritage site/defence establishment etc. is located in the area.
- 3). Project may not effect the survival of wild animals as the project is near the human Habitation.
- 4). No violation of the Act has been carried out by the user agency as the work for this proposal is yet to be started which shall be allowed only after clearance of the proposal by competent Authority.

Specific Recommendation:-

The proposal may be accepted as per guidelines of Govt. of India, As the forest land proposed for diversion is essentially required for construction of road from Jourakhurd to Shamdlian of Bhaderwah Forest Division to provide road connectivity to the rural population. 3. Plantation Model:

Compensatory afforestation over an area of 1 ha. of degraded forest land is proposed to be raised. The area selected for this purpose falls under reboisement working circle as per the prescription of the current working plan (2013-14 to 2023-24).

Presently the area has scattered Kail trees. Whole of the plantation of 1 ha. will be raised in a single compact block inside the degraded forest for such purpose. The area indentified for plantation has also been shown on the attached map. Plants @ 700 plants per ha. will be planted. Thus, 700 plants under this diversion proposal will be

planted on the proposed site. The species to be planted will be mainly Deodar/Kail (Cedrus Deodara / Pinus wallichiana) plants. The plantation will be raised in the following year after the approval of FCA proposal and further maintenance and beating up of failures will be done for the subsequent ten years. The scheme will be implemented by the Forest Department through Divisional Forest Officer, Bhadarwah Forest Division. The financial outlay for compensatory plantation scheme is Rs. 122989.00. Certificate of the DFO Bhadarwah regarding suitability of area identified for compensatory plantation is attached. The area selected for compensatory plantation will be approachable from existing proposed road. The monitoring will be done as per existing monitoring mechanism in the Forest Department at present and also as per G.O.I. instructions.



1. Technical details:-


Technical details of compensatory afforestation scheme are as follows:-

- (a) General Details:- An area of 1 ha. will be taken up for planting under compensatory afforestation scheme in forest compartment No. 36/Jai in a single compact block. The area will be protected by using square PCC fence posts with barbed wire fencing and by planting Deodar/Kail species plants. Plants will be planted @ 700 plants per ha.
- (b) Spacing:- 2.50 mts x 2.50 mts.
- Species to be planted :- Deodar/Kail (Cedrus deodara / Pinus wallichiana) .
- (c) Plantation Method:- Nursery grown two to three years old plants of Deodar/Kail species will be planted in the pits of size 45 x 45 x 45 cm in the selected area. The plantation will be maintained for subsequent 10 years in which beating up failures will be done. The plantation will be rainfed.
- (d) Soil and Moisture Conservation Works:- Minor soil conservation works like gully plugging, check walls will be done where ever required.
- (e) Protection (Fencing, Watch Man, People's Participation etc.):- Area will be protected from grazing by erecting barbed wire fencing around the plantation site. Watch & ward shall be provided by engaging a watch man. Fire Protection shall also be provided by this watch man.
- (f) Proposed Monitoring Mechanism:- The plantation will be monitored as per existing monitoring mechanism in the forest department. The plantation will also be monitored by GOI representatives as per instructions.
