
## Site Inspection Report (Proposed Jasidih-Giridih 220 KV Transmission Line of JUSNL)



Site inspection was done by the undersigned on 25.10.2018 in the presence of forest officials & officials of JUSNL, Transmission Division, Deoghar. The proposed site for diversion constitutes 40.789 ha of forest land, out of which 14.169 ha is notified protected forest (PF) & 26.620 ha is Jungle-Jhari land. Forest Land proposed for diversion is located in Giridih Range of Giridih East Forest Division. The total length of project in Giridih East Forest Division is 36.34092 Kms. No rare endangered species of flora and fauna is noticed in this area. The vegetation found in the proposed forest land for diversion are mainly Eucalyptus, Palas, Neem, Siris, Acacia sps, Jamun etc. No protected area/archeological heritage site/ defense establishment or other important monuments are located in the concerned area.

Total 40.789 ha Forest Land proposed for diversion is located in Giridih Range of Giridih East Forest Division.
