RECOMMENDATION OF THE CHIEF CONSERVATOR OF FORESTS, HILL CIRCLE, WEST BENGAL IN CONNECTION WITH THE PROPOSAL FOR DIVERSION OF 0.224 Ha. FOREST LAND UNDER THE JURISDICTION OF KURSEONG FOREST DIVISION FOR ROLLOUT OF G BROAD BAND SERVICES IN FAVOUR OF JIO INFOCOM LTD.

Reliance Jio Infocomm Ltd. has proposed the land diversion proposal over 0.224 Ha. in Compartment 5 and 3 of Mahaldiram Block of Gairigaon Beat within the jurisdiction of Bagora Range under Kurseong Forest Division, is a bare minimum for the purpose of Rollout of 4G Broadband Services along Hill Cart Road, through forest land.

The proposal for land diversion of 0.224 Ha. of forest area is recommended for acceptance, for the expansion of communication facilities from strategic point of view, in the public interest.

The proposed area over 0,224 Ha. falls under Compartment 5 and compartment 3 of Maldhiram Block of Gairigaon Beat within the territorial jurisdiction of Bagora Range under Kurseong Division. There is no issue of felling of trees for the proposed site and it does not falls under any designated wildlife habitat. It is a barest minimum for the purpose. The proposed area if diverted for the purpose mentioned ,would cause minimum interference to the wildlife habitat and movement of wildlife.
