The forest area demanded is already diverted to Maharashtra State Road Development Corporation Limited for Nagpur Mumbai Super Communication Expressway (Package-V) and Bharat Petroleum Corporation Limited for laying underground petroleum pipeline from Mumbai to Manmad.

Recommendations of the Inspecting Officer (CCF/CF/DCF)	:	<p>The proposed pipeline route is the most suitable route from Mumbai to Nagpur, as the forest land is already diverted to MSRDCCL for Nagpur Mumbai Super Communication Expressway (Package-V) and BPCL for laying underground petroleum pipeline from Mumbai to Manmad and the proposed Natural Gas Pipeline is passing through the RoW of MSRDCCL and BPCL. Hence the proposal for Re-Diversion is recommended for acceptance as per the Specific Recommendation enclosed with Part-II.</p>
