

## SITE INSPECTION REPORT

M/s Reliance Jio Infocomm limited, No : 89, Dr Radhakrishnan Salai, Mylapore, Chennai -4 has seeking prior permission of Central Government under Section 2 Forest (Conservation) Act, 1980 for diversion of 0.03132 ha for implementation of the project for laying of Optical Fiber Cable (OFC) along the road side from Royandapuram to Melsiruvalur road section over a length of 1.044 Kms across Pavunjiattu RF in Villupuram District vide their online uploaded proposal No : FP/TN/Others/38123/2019.

I inspected the project area on: 24.11.2022. During the field visit, Range staff is there. They have proposed for <sup>a</sup>lying of Optical Fiber Cable (OFC) falls adjacent to existing road in Pavunjiattu R.F of Kallakurichi Range of Villupuram Division hence this proposal is recommended and CA may be insisted in the proposal as vast stretch of this forest is open and moderate dense forest. 


## RECOMMENDATION
