With respect to above subject, Executive Engineer (Bridges), Brihanmumbai Municipal Corporation has applied for diversion of 0.1702 Ha Forest (Mangroves) land for proposed construction of Bridge at Dharivali Village at Marve road, P/N ward. to Divisional Forest Officer, Mumbai Mangrove Conservation Unit vide reference No. 01 to 03. Divisional Forest Officer, Mumbai Mangrove Conservation Unit has submitted proposal to this office for further action vide reference No. 04

1. The project authority has submitted hard copies of the proposal to Divisional Forest Officer, Mumbai Mangrove Conservation Unit office. The details are as below:

- 2. The Reserved Forest land proposed for the non-forest activity was jointly inspected with project proponent by undersigned authority on 10/02/2022.
- 3. Compensatory afforestation detailed are enclosed on Page No. 57 & 58.
- 4. User agency has submitted undertaking for compliance of condition regarding Schedule Tribes and Other Traditional Forest Dwellers (Recognition of Rights) Act 2006, at the earliest.
- **5.** There are 97 trees of *Avicennia marina* species of various girth in the area proposed for diversion. Girth and species wise breakup are as under;

- 6. There is no violation of Forest (Conservation) Act 1980 & its guidelines.
- 7. The proposed forest land belongs to Eco value II and density of forest is 0.6 (Dense Forest)
- 8. The user agency has submitted an undertaking to defray the cost of Net Present Value of forest land proposed for diversion, cost for raising Compensatory afforestation & cost of tree felling
- 9. The proposal involves felling of mangrove trees. Hence, user agency will require to obtain necessary permission from Bombay High Court for the project before the commencement of work.
- 10. Construction activities of the proposed project fall within the CRZ area. Hence, user agency will require to obtain permission from MCZMA under the provision of CRZ Notification, 2011.
- 11. The proposed project is 7.3 km from the boundary of Sanjay Gandhi National Park and 16.7 km from Thane Creek Flamingo Sanctuary.
- 12. The Divisional Forest Officer, Mumbai Mangrove Conservation Unit is recommending the proposal for approval.

Scrutiny of the proposal has been carried out by this office. 3 sets of proposal are submitted herewith for favor of further action.
