A proposal has been received by this office from *Hindustan Petroleum Corporation Limited Retail Outlet on Tulsipur-Koylabasa Road (MDR) in Km No. 7 (CH. No. 6.800, LHS) at Gata No-224, Village:-Madarhwa, Tehsil:-Tulsipur, District:- Balrampur* on dated 29-03-2022 for **Forest Clearance Under Forest (Conservation) Act, 1980 of 0.157853 ha. Protected Forest** of forest land for non forestry purpose. The subject envisages the use of forest land for **construction of Approach Access for Retail Outlet through forest land in 0.157853 Ha. (Village-Madarhwa) in District- Balrampur (U.P.)**. The site inspection of the land involved in the proposal has been done by me on dated 17-12-2022

On inspection of the site, it is found that the land required by the user agency is a **Protected Forest** measuring **0.157853 ha**.
