


Site inspection report of the DCF

Date of inspection : 17.10.2022

The proposed construction of two laning with paved shoulder of stretch from Junction of NH-22 near Hazipur to Junction of NH-122 at Bachhwara via Mahanar and Mohiuddin Nagar of NH-122B Samastipur District (Ch. Km 34+900 to Km 70+041) of road Project of National Highway Division, Bihar Sharif lies in starts from Palwaiya and ends at Bajitpur of NH-122B in Samastipur District via Mahanar and Mohiuddin Nagar of NH- 122 B. Construction two laning with paved shoulder of stretch of (Ch. Km 34+900 to Km 70+041) proposed Forest area is 58.5085 Ha. The proposed area is a part of P.F. (notification no.- 189E/190E dated - 16.02.1994). Total trees/plants are affected 6063 out of which felling of 4332 (Four Thousand Three Hundred Thirty Two) trees is involve. and Translocation of 1731 (One Thousand Seven Hundred Thirty One) trees. Proposed land to be used as Construction of two laning with paved shoulder, stretch of road. As per the observation made on the field and the facts stated above, the total land of the road side P.F. proposed for diversion for Construction of laning with paved shoulder, stretch of road is 58.5085 ha. GPS Reading: N- 25°35'8.58. E- 85°32'8.74" Palwaiya and N-25°35'30.56". E-85°47'13.38". There is no rare/ endangered/ unique species of flora & fauna found in the area, neither any archaeological site is present near the proposed site.

The user agency has not done any construction on the proposed site.

Site inspection report of the DCF

Date of inspection - 19/10/22


The proposed strengthening & widening proposal of Hajipur-Bachwwara via- Mahnaar - Mohadinagar Road starts from Murlitol (Bachwwara) in Begusarai District. The proposal is for widening & strengthening of Km 70.041 to 72.951 Km of the said road. A portion of the road (03 km) falls in Begusarai district of this Division. The roadside is declared as protected forest by Govt. of Bihar notification no. 97/91 dated 15.02.1994.

A total no. of 405 trees present on the road side are supposed to be felled/Translocate during the strengthening & widening of the road. In this way a total of 405 plants are going to be destroyed on acceptance & execution of the proposal. The detailed joint enumeration list of 405 trees are enclosed in the proposal. A summary of the list is enclosed separately.

A compensatory afforestation scheme for 981 plants has been proposed and attached with the proposal. The proposed plantation scheme for 981 plants is about three times of the number of plants going to be felled. A Certificate about suitability of the area for plantation is attached separately.

There is no rare/endangered/unique species of flora & fauna found in the area. Neither any archaeological site is present near the proposed diversion.

The Forest area required for the project is barest minimum, justified and recommended for acceptance of the proposal. There is addition to it there is 405 trees on the site. The user agency may be directed translocate/felling the work protecting that trees..
