

## Inspection note.

The proposed site was inspected on 02-11-2022. The factual details regarding the Proposed site and consequent findings are stated below:-

1. The Proposed construction of two Playing with paved shoulder of stretch from Hajipur Junction of NH-122 at Bachhwara via Mahanar and Mohaddinagar of NH-122B Samastipur District.(Ch.km 34+900 to km 70+041) of road project of National Highway Division, Bihar Sharif lies in starts from Palwaiya and ends as Bajitpur of NH-122B the proposed area is 58.5085 Ha. for widening and strengthening of road. The Proposed area is a part of protected Forest vide Government of Bihar Notification No-189E/190E dated 16-02-1994. The proposed land required in order to establish for widening and strengthening of road. is 58.5085 Ha as per map attached with this Proposal.
2. The total number of plants/trees are affected is **6063 out of which felling of 4332 (Four Thousand Three hundred Thirty Two) trees are involve and 1731 (One thousand Seven Hundred Thirty one) trees are Translocated.** There are no rare/endangered/unique species of flora & fauna found in the area. No archaeological site is present near the proposed site.
3. The user agency has not done any work on the site.

1. The Proposed land is used for widening and strengthening of road. The proposed forest area is on Hajipur-Bachhwara vava Mahnar Mohaddinagar NH-122B Road. The total area is 70.041 to 72.951 km a portion of the 03 km falls in Begusarai District. The Proposed area is a part of protected Forest vides Government of Bihar Notification No-189E/190E dated 16-02-1994. The proposed land required in order to establish for widening and strengthening of road. is 3.1586 Ha. as per map attached with this Proposal.
2. The total number of plants/trees are affected is **405 (Four hundred Five) trees are involve to be felled/Translocate during the strengthening and widening of the road and 981 (Nine Hundred Eighty one) plants has been compensatory afforestation scheme is attach with the proposal.** There are no rare/endangered/unique species of flora & fauna found in the area. No archaeological site is present near the proposed site.
3. The user agency has not done any work on the site.
