Earlier on submission of case it was discovered that the trees coming in ingress and outgress of the premises were felled illegally for which Damage Report No.7015/71 dated:30-04-2012 has been issued and also on inquiry was conducted by the then Additional Divisional Forest Officer based on the facts the case was not recommended. Letter dated.15 th July, 2004 of Minister of Environment & Forests instructs "The minimum distance between two fuel Stations on each sides of the road should not be less than 5 Km, outside the city limit on Highway. In the present case there are 3 fuel stations running within 5 Km. on either side of the petrol Pump & also there is the case of illegal removal of trees as already stated. Now the case has been applied afresh. At present there are no trees which may come in ingress & outgress of the proposed site as they are removed but the previous implication are the same. In the above background the case is unfit for recommendation. |
