

## Recommendation Report of the Divisional Forest Officer,

### Deoghar Forest Division, Deoghar

I inspected the forest area proposed for diversion of 132 kV D/C Jasidih-Madhupur Transmission Line on 29<sup>th</sup> September 2018. The proposed transmission line passes through the forest land of following villages:

The crop density of forest area in this linear forest diversion proposal is 0.2 to 0.4. Mainly few trees of Palash of girth class between 60 cm to 90 cm are present.

The proposed area is slightly prone to erosion. Any Protected/Archaeological site/Defence establishment or any other important monuments are not located in the proposed forest area.

There is violation of Forest Conservation Act, 1980. **All Transmission Towers** have already been laid out on the Jungle/Jungle Jhari/Protected Forest and connectivity between these Transmission towers through wire conductors has also been done covering total area of 19.46864 ha. which is violation of Forest Conservation Act, 1980. Thus **19.46864 ha.** of forest land has already been used by the user agency before getting the prior approval from the Government of India in contrary to the provisions of the Forest Conservation Act-1980.

The user agency has explored all the alternative paths for this project and the proposed alignment is the most suitable one. Jharkhand is having acute shortage of electricity production. Hence this proposal may be accepted with the provisions of Penal NPV and Penal CA which Government may deem fit.
