

**Subject:** Diversion of 1.62 ha. of forest land in favour of M/s Dinesh Butail Hydro Power for the construction of 5 MW Grahan Kasol Small Hydro Electric Project within the jurisdiction of Parvati Forest Division, Distt. Kullu, H.P.

Sir,

It is brought to your kind notice that subject mentioned proposal, which was uploaded by the User Agency i.e. M/s Beena Butail Hydro Power as Proposal No. FP/HP/HYD/36856/2018 dated 18.11.2018 on the MoEF Website which was processed by DFO Parvati and submitted to this office for further necessary action. The same has been uploaded after going through the new guidelines of Forest Conservation Act, 1980 on dated 02.09.2019 by the undersigned. Two numbers proposal folders (hard copy) received from the User Agency and processed by DFO Parvati duly recommended by the undersigned is submitted for favour of kind information & further necessary action at your end please. All the documents pertaining to the proposal uploaded online in MoEF website are being sent in hard shape.

In this context, the User Agency has prepared the Compensatory Afforestation (CA) Scheme for 3.25 ha. in lieu of diversion of 1.62 ha. of forest land which is placed in each proposal folder at page-52 to 63 and undertaking for the payment of NPV has been given by the U/A at page-42-43. FRA Certificate has not been attached and in absence of that the User Agency has given an undertaking placed in each proposal folder at page-44 in which it has been undertaken by the User Agency that the process regarding FRA Certificate is under process with the competent authority. As and when FRA certificate is received from the competent authority, the same will be submitted to your office. The non-availability land certificate for CA issued by District Collector and DFO Parvati is placed in the proposal folder at page 63 & 64.

In this regard, it is further brought to your kind notice that as per the directions issued by the Additional Chief Secretary (Forests) to the Govt. of H.P. Shimla vide letter No. FFE-B-F-B-G (6)-7/2006 dated 02.04.2009, the Techno Economic

Clearance (TEC) and Implementation Agreement (IA) will be provided by the U/A before the final approval is granted under FCA, 1980.

In view of the facts narrated above, it is therefore, requested that necessary approval under Forest (Conservation) Act, 1980 in the instant proposal may kindly be obtained from the competent authority and conveyed to this office please.
