Today proceeded and inspected the area proposed for diversion at Mangalpally Reserve Forest Block in Compt. No. 269 of Ibrahimpatnam Section in Ibrahimpatnam Range of this Division along with the concerned Forest Range Officer, Ibrahimpatnam and his staff the proposed area 0.2971 Ha to be diverted for Laying of Liquid Petroleum Gas (LPG) Pipe line along with Optical Fiber Cable (OFC) in the existing Right of way in favour of M/s. Hindusthan Petroleum Corporation Limited and the following observation are made.

- 1) The proposed area for diversion is falling the ORR which was already diverted to HCPL earlier.
- 2) 232 Nos. of existing trees in the proposed area. The trees are enumerated and listed as per the PCCF instructions the same are test checked.
- 3) The total Forest area in Compt No.269 of Mangalpally Reserve Forest is 515.20 Ha.
- 4) The Forest area of this Compartments Areas is Tropical Dry Deciduous Open Forest Type.
- 5) The diverted area to be permanently demarcated on the ground at the cost of user agency and the total length of the area is 1485.50 Mtrs and width 2.00 Mtrs and the total area comes to 0.2971 Ha.
- 6) There are no rare / endangered / unique species of flora and fauna in this proposed area and also there are no protected archaeological / heritage site / defense establishment etc.,)

It is observed that, there is no private / government land is available for diversion.
