SITE INSPECTION REPORT- NOT BELOW THE RANK OF DCF

(for the forest land to be diverted under FCA)

5.1 A proposal has been received by this office from **Executive Engineer Ty.** Division P.W.D.Bhowali Nainital for diversion under FCA-1980) of 1.7425 ha. of forest land for non-forestry purpose. The project envisages the use of forest land for construction of **Motor Road from Nadgal Village under CM Scheme at Distrit Nainital** The site inspection of the land involved in the proposal has been done by me on dated 20-07-2018

5.2 On inspection of the site, it is found that the land required by the user agency is a RF/PF/un-classed/Other forests measuring 1.33 ha. RF

5.3 The requirement of forest land as proposed by the user agency in Co1.2 part-1 is unavoidable and is barest minimum required for the project. **Yes**

उक्त प्रस्तावित मोटर मार्ग 2.500 किमी० लम्बाई तथा 7 मीटर चौड़ाई में प्रस्तावित किया गया था । उक्त मोटर मार्ग में 312 वृक्ष विभिन्न प्रजाति के वृक्ष प्रभावित होते हैं जिसमें बाँज प्रजाति के 9 वृक्ष भी सम्मिलित हैं । जिसमें आरक्षित वन भूमि 1900 मीटर यानि 1.33 है० तथा नाप भूमि 600 मीटर यानि 0.42 है० प्रभावित होती हैं । उक्त प्रस्तावित मार्ग के समरेखण में आरक्षित वन भूमि में 312 वृक्ष विभिन्न प्रजाति के जिसमें 0-10 व्यास सेमी० के 71 वृक्षों में से 2 वृक्ष बाँज प्रजाति के सम्मिलित हैं, प्रभावित होते हैं। ऑन लाईन 241 वृक्षों की पृविष्टी की गई हैं जिसमें 7 वृक्ष बाँज प्रजाति के सम्मिलित हैं। 0-10 व्यास सेमी० के 71 वृक्ष की पृविष्टी ऑन लाईन टिप्पणी में की गई हैं। स्थल निरीक्षण के दौरान सहायक अभियन्ता अस्थाई खण्ड भवाली तथा स्थानीय जनप्रतिनिधियों द्वारा अवगत कराया गया कि उक्त मार्ग के निर्माण से ग्राम महतौलीयागाँव नगदल, स्यालीगाँव तोक, सुन्दरखाली तोक तथा दीनी जिनकी जन संख्या 1600 हैं लाभान्वित होते हैं । अतः प्रस्ताव को भारत सरकार की स्वीकृति हेतु अग्रसारित किया जाता हैं ।
