- (5) The Deputy Conservator of forest Buldana Division, Buldana has certified that the proposed project is beyond 10 km of the boundary of the Protected area.
- (6) There is no cutting and felling of trees involved in the project the certificated given by Deputy Conservator of Forests, Buldana Division, Buldana.
- (7) The Optical Fiber underground Cable Line passing through S.H-13 from route section Km. 26/00 to 47/00 Rajur, Shiwar in Motala Taluka Dist. Buldana alongwith Right of Way.
- (8) The user agency has submitted an undertaking to defray the cost of Compensatory Afforesation of the forest land proposed for diversion.
- 3.00 The Government of India has accorded general approval under section -2 of forest (Conservation) Act 1980 vide letter no. F.No.11-9/98-FC, dt.7/09/2015 for the underground laying of optical fibre cables, telephone lines, drinking water supply pipelines, CNG/PNG pipelines within the existing right of way of roads and petroleum pipelines. The proposed Optical Fiber underground Cable Line is passing through S.H-13 from route section Km. 26/00 to 47/00 Rajur, Shiwar in Motala Taluka Dist. Buldana alongwith Right of Way.

In view of this, the proposal is recommended for approval under section - 2 (ii) subject to the following conditions:-

- The legal status of the land shall remain unchanged.
- ii) The Optical Fiber Cable Line will be laid within maximum size of the trench of 1.00 m depth & 0.45 m width. With cable line under the PVC Pipeline.
- The land under project will be reclaimed by the user agency for which the agency shall submit a bank guarantee at the rate of Rs. 50/- per running meter and an undertaking to that effect shall also be submitted. If the agency fails to reclaim the land to the satisfaction of Deputy Conservator of Forests concerned, the cost for reclamation will be recovered from the bank guarantee.
- iv) If the cable is going to be laid in the formation width of the road, then additional charges in form of bank guarantee shall be given at the rate of Rs.35/- per running mtr. Similarly for reclamation of side drain and for tarred portion, the guarantee will be at the rate of Rs. 300/- per mtr. and Rs.750/- per mtr. respectively. An undertaking shall be obtained from the user agency that it has

agreed to make good any loss to Forest/ Environment while laying the cable in the forest area and during maintenance of the same in future.

- For further maintenance of the project, the agency shall obtain permission from the concerned V) Deputy Conservator of Forests as and when required.
- The forest land shall not be used for any purpose other than specified in the proposal. vi)
- No felling of trees shall done during the implementation of project. vii)
- The user agency will be authorized to lay the Optical Fiber Cable outside the confines of the viii) protected area after compliance of this order. Any breach of the conditions by the user agency will be treated as violation of the provision of Forest (Conservation) Act, 1980.
- No new forest area beyond the Right of Way of existing road should be broken for laying Optical ix) Fiber Cable.
- All the amount received from the User Agency under the project shall be transferred to the Adhoc Compensatory Afforestation Fund Management & Planning Authority (CAMPA) in A/c No. SB01025218 of Corporation Bank, Block-11,CGO Complex, Phase-I, Lodhi Road, New Delhi-110 03 and compliance will be reported to this office.
- The compensatory afforestation will be raised on 1.00 ha. of suitable degraded forest land at the xi) cost of project authority.
- The Chief Conservator of Forests (T), Amravati shall report the details of amount recovered from xii) the Project Authority towards the cost of compensatory afforestation at prevalent rate and all other cost required as per rules in due course of time.
- All the conditions stipulated by the Forest Department shall be binding on the User Agency. xiii)
- This sanction is subject to the final clearance by the Department of Information & Technology for xiv) the Project and SH-13.
- The User Agency will make good the land after use/maintenance XV)

It is, therefore, requested that in view of the general approval accorded by Government of India vide letter dt.7/9/2015 for the underground laying of optical fibre cables, telephone lines, drinking water supply pipelines, CNG/PNG pipelines within the existing right of way of roads and petroleum pipelines, the Government of Maharashtra may kindly be moved for diverting 0.3375 ha forest land for laying underground Optical Fiber Cable alongwith SH 13 from route from 26.00 to 47.00 Km.Rajur, Mohagaon & Buldana, under section 2 (ii) of Forest (Conservation) Act-1980.
