FIELD INSPECTION NOTES OF A.VENKATESHWARLU, DISTRICT FOREST OFFICER, MEDCHAL IN SHAMIRPET RANGE OF MEDCHAL DIVISION.

Inspected the proposed forest area on <u>03.02.2021</u> for diversion of 0.9678 Ha of forest land for Widening and Strengthening of PWD Road to Yadaram from Km 0/0 to 7/600 in between Rajbollaram Thanda & Yadaram Village of Yadaram RF in Medchal-Malkajgiri District in favour of Executive Engineer (R&B), Medchal-Malkajgiri District. The proposed road is passing through Yadaram RF which is notified U/s 19 of Hyd Forest Act,1355 Fasli. As per notification a cart track is admitted as a right of way. However the user agency is asking for diversion of entire Road width including cart track. The proposed road is entering in Compartment No.221of Yadaram Forest Block at SI.No.RC1:17.65452565 N, 78.56042328 E and follows upto S.No.RC17: 17.66128911N, 78.56604901 E (As shown in the DGPS Map) with a length of 967.797Mtrs and width of 10.0 Mtrs. Further, the Forest Range Officer, Shamirpet has submitted enumeration of trees report and its value in the proposed diverted area.

As per the enumeration statement, the value of growth/produce is Rs.117129/- and 10 times of plants to be raised (1070 plants) in degraded forest area for (107) No. of trees to be felled. Accordingly ACA Scheme i.e. (10) times of planting for the trees to be felled is prepared for Rs.38.702 lakhs for raising &(10) years maintenance of plantation in Kandlakoya RF Block in Compt. No.217 of Dulapally Range. The enumeration of trees in the proposed diverted area in the prescribed proforma and ACA Scheme proposals are enclosed herewith.

Further it is also found that there are no any rare/endangered/unique species of Flora & Fauna found and no protected archeological/heritage site/defence establishment or any other important monument is located in the area and it will not affect the existing forest.

The specification of the proposed road is shown hereunder:-
