

Field inspection notes of Sri K.Srinivasulu, S.F.S., Forest Divisional Officer, Kamareddy on 22-10-2021 in Machareddy Range on 23-10-2021 in Kamareddy Range and on 09.12.2021 in Nagireddypet Range area proposed for diversion of 0.2306 Ha of Forest land in Kamareddy division of Kamareddy District for laying of Optical Fiber Cable along the road within the existing RoW for execution of T- Fiber project in favour of M/s Telangana Fiber Grid Corporation Limited

I have inspected the area proposed for laying of Optical Fiber Cable along the road within the existing RoW for execution of T- Fiber project in favour of M/s Telangana Fiber Grid Corporation Limited in Kamareddy Division jurisdiction, which is passing through reserve forest area in Kamareddy Range, Machareddy Range and Nagireddypet Range.

Machareddy Range:

The total area of Optical Fiber Cable passing is 0.0794 Ha. in Machareddy Range. I have verified the area falling in Machareddy Part block, length is 1765.35 mts. width is 0.45 mts.

The Forest Range Officer, Machareddy inspected the site on 28.9.2021 the proposed area falling in 0.0794 Ha. Compt.No.550, Machareddy Part Forest Block, Ghanpur (M) Beat of Machareddy Section and the geo location with GPs starting point is Lat.18.34730 Long.78.53078 and ending point geo location is Lat. 18.35136 Long.78.54445 (T 334 to T 318) and also reported that there is no vegetation found in the proposed area.

I have also inspected the proposed diversion of forest land for laying of Optical Fiber Cable along the road within the existing RoW for execution of T- Fiber project in favour of M/s Telangana Fiber Grid Corporation Limited on 22.10.2021, and no vegetation found in the proposed area.



Further, it is submitted that I have searched for the other alternative but there is no alternative land available except the present proposal. This is a bare minimum area i.e., regard for laying of optical fibre cable by the user agency. There are no encroachments and claims in the RF area that attracts the RoFR Act 2006. The area is free from encroachment. There are no claims pending in RoFR Act 2006. There are no endangered species that are caused or harmed due to laing of optical fibre cable by M/s Telangana Fiber Grid Corporation Limited, till the day of inspection no work has been strated in violation of Forest Conservation Act, 1980.

Kamareddy Range:

The total area of Optical Fiber Cable passing is 0.0780 Ha. in Kamareddy Range. I have verified the area falling in Manchippa block, length is 1734.37 mts. width is 0.45 mts.

The Forest Range Officer, Kamareddy inspected the site on 28.9.2021 the proposed area falling in 0.0780 Ha. Compt.No.457/1, Manchippa Forest Block, Kalwaral Beat of Kalwaral Section and the geo location with GPs starting point is Lat.18.49183 Long.78.21957 and ending point geo location is Lat. 18.47695 Long.78.22090 (T 265 to T60) and also reported that there is no vegetation found in the proposed area.

I have also inspected the proposed diversion of forest land for laying of Optical Fiber Cable along the road within the existing RoW for execution of T- Fiber project in favour of M/s Telangana Fiber Grid Corporation Limited on 23.10.2021, and no vegetation found in the proposed area.



Further, it is submitted that I have searched for the other alternative but there is no alternative land available except the present proposal. This is a bare minimum area i.e., regard for laying of optical fibre cable by the user agency. There are no encroachments and claims in the RF area that attracts the RoFR Act 2006. The area is free from encroachment. There are no claims pending in RoFR Act 2006. There are no endangered species that are caused or harmed due to laing of optical fibre cable by M/s Telangana Fiber Grid Corporation Limited, till the day of inspection no work has been strated in violation of Forest Conservation Act, 1980.

Nagireddypet Range:

The total area of Optical Fiber Cable passing is 0.0732 Ha. in Nagireddypet Range. I have verified the area falling in Shetpally Sangareddy block, length is 1627.12 mts. width is 0.45 mts.

The Forest Range Officer, Nagireddypet inspected the site on 18.10.2021 the proposed area falling in 0.0732 Ha. Compt.No.695, 741 & 742 Tandoor Forest Block, Dharmareddy Beat of Nagireddypet Section and the geo location with GPs starting point is Lat.18.11379 Long.78.10093 and ending point geo location is Lat. 18.12073 Long.78.08751 (T 298 to T315) and also reported that there is no vegetation found in the proposed area.

I have also inspected the proposed diversion of forest land for laying of Optical Fiber Cable along the road within the existing RoW for execution of T- Fiber project in favour of M/s Telangana Fiber Grid Corporation Limited on 09.12.2021, and no vegetation found in the proposed area.



Further, it is submitted that I have searched for the other alternative but there is no alternative land available except the present proposal. This is a bare minimum area i.e., regard for laying of optical

fibre cable by the user agency. There are no encroachments and claims in the RF area that attracts the RoFR Act 2006. The area is free from encroachment. There are no claims pending in RoFR Act 2006.
