- 5.00 The Deputy Conservator of Forests, Alibag has certified that the proposed land is not part of the Karnala Bird Sanctuary and certified that the proposed area is not part of existing National Park / Wildlife Sanctuary, Nature Reserve or not included in Eco Sensitive Zone of Karnala Bird Sanctuary. The proposed area of the project is 11.280 km. from the boundary of Eco Sensitive Zone of Karnala Bird Sanctuary and further certified that the proposed area i.e. 9.9249 ha. for rehabilitation & up-gradation of existing highway to 2 lane/4 lane with Paved Shoulder under configuration from Pen-Khopoli (Km. 00+000 to Km. 33+328) Section of NH-166D (Pen-Khopoli) on Engineering Procurement & Construction (EPC) Basics in Raigad District in the State of Maharashtra will not have any adverse effect on the Wildlife within National Park/Sanctuary.
