

**SITE INSPECTION REPORT NOT BELOW THE RANK OF DCF/ DFO**

**(for the forest land to be diverted under FCA)**


A proposal has been received by this office from Indraprastha Gas Limited on dated 12.01.2021 for diversion (under FCA-1980) of 0.7900 ha. of forest land for non forestry purpose. The project envisages the use of Protected Forest land in NH-24 Ghaziabad-Hapur Road for construction of laying of 12" NB Carbon Steel Gas Pipeline, 125 mm MDPE & 50 mm Dust in same trench along with road on NH-24 (New NH-9) (Delhi-Lucknow Road) from Km. 34.00 to Km 49.800 Total Km. 15.80 & 0.7900 Ha. in Forest Division Hapur, District Hapur- UP. The site inspection of the land involved in the proposal has been done by me on 25.02.2021.

User Agency has proposed an alignment that requires 0.7900 Ha. forest land. **The proposal is recommended for approval.**

1. On inspection of the site, it is found that the forest land required by the user agency measuring 0.7900 ha. stated in column-2 of Part-I is **unavoidable and barest minimum required for the project.**
2. Whether any rare / endangered / unique species of flora & fauna is found in the area- **NIL**
3. Whether any protected archaeological/ heritage site/ defense establishment or any other important monument is located in the area- **NIL**

The site has protected forest of area 0.7900 ha. which is required for Construction of laying of 12" NB Carbon Steel Gas Pipeline, 125 mm MDPE & 50 mm Dust in same trench along with road on NH-24 (New NH-9) (Delhi-Lucknow Road) from Km. 34.00 to Km 49.800 Total Km. 15.80.

The proposal is recommended in public interest.
